Part 1 - TREA Activities

Life Member since 1997. I originally joined TREA Chapter 97 in Dallas, TX, but lived in Superior, WI. I decided to organize a Chapter in Superior and formed Lake Superior Chapter 119 in three months chartering the chapter with 42 members in June 2002. We now also have Retired Active Component members in the Chapter. The Chapter is very active and have received the Small Chapter Award four times. I have also received the Small Chapter President Award four times. I have always looked out for the Veteran's. I represented the Chapter and TREA at a rally to save and support the VA Outpatient Clinic in Superior 26 years ago. I also spoke out when the lease renewal came up for the clinic which was renewed for another 25 years. I am still involved with them looking out for their welfare through TREA's organizations and other Veteran Organizations. You will see more on this in the Community Activities section.

I have served previously on the TREA BOD from 2005 to 2013 and again from 2020 - 2022. I have served on numerous committees during this time, most recently as the Scholarship Committee Chairman. I have also served on the TREA Memorial Foundation from 2014 to 2019 and served on numerous Foundation committees. Elected as Chairman of the Foundation from 2017 - 2019. I was responsible for proper recording and accounting of the Foundation's finances. The Foundation gave out hundreds of thousands of dollars to Veteran's who needed help each year. In 2017, I approved the creation of the Foundation's Holiday Program - a program that provides food, clothing, gifts and financial support to for the families of deployed and wounded soldiers .

May 1965 to December 1995 , completed 30 years, six months of duty with the WIARNG. 1965 to 1981 - attended weekend drills and two weeks active duty training. Given accelerated Promotion to E-7 on December 28, 1973 because of work ethic and performance. In December 1981, I Started Active Duty Active Guard Tour (AGR) under Title 10 until retiring in December 1995. I attended many Military and Motivation schools to include Sales Management Training of Atlantic, Inc., Career Planning and Workshop Programs, Career Planning Workshop International Seminar, Reserve Components Instructor Course, Army National Guard Attrition Course. I received many awards during my time in the service to include State Retention NCO of the year for 1991 and went on for the National Guard Retention NCO of the year, but was eliminated at National level.
