It is a moment of great privilege and pleasure that I start this last year in office as your National President by providing a little insight of the many accomplishments that this last year has afforded our association. For instance, our business meeting held in San Diego was one of great success where we had members from across the country in attendance, in person and video conferencing. In addition, I would like to provide insight on what the future holds for The Enlisted Association and being a member of such an outstanding veteran's organization.

First, a renewed focus on legislative efforts and centralized communication to such efforts. TREA has been quoted in at least 28 press releases and by numerous Congressmen and Senators, since January 2021. We have accom-

plished many feats, being first on the ground for passing of the PAWS ACT and continuing the efforts in Congress with Toxic Exposure Legislation. TREA continues to be front and center on the issue of Military/Veterans Mental Health and Suicide Prevention and PTSD. We continue to remain hard at work securing co-sponsors for Concurrent Receipt (VA Disability /DOD Retirement Pay Offset), and hope to see successful passage of HR 1282, The Major Richard Star Act this year.

Second, the TREA GIVES program and its successful launch with providing support for over 100 veterans/active duty at a value of \$75,000 for the 2021 calendar year. This program directly gives the much needed support within twenty-four hours turn around. Getting relief to where it is needed at a moment's notice. More programs and more ways to help will come in 2022.

Third, I would thank the National Auxiliary President and the Auxiliary Board of Directors for working with TREA to sign a new affiliation agreement that is beneficial to both parties. We look forward to this renewed relationship.

The last item that I want to mention is the Holiday Program, an integral part of the TREA GIVES program. This program is a much needed, and deserved, morale boost for our wounded/deployed service members, as it is a gesture of thanks and gratitude for their own and their family's service and sacrifice. TREA GIVES provides gifts, clothing, and food during the holiday season to 100 military families across the country.

As a national organization, we have accomplished many tasks and established framework for the continued success of The Enlisted Association for the foreseeable future. Please continue to support these efforts.

2022 Annual Membership Meeting, San Antonio - Update

One of the responsibilities of the National Board is to plan appropriately for the foreseeable future of the TREA Enterprise. This means taking into account its financial standing as well as the financial feasibility of planned membership activities. While no one has a crystal ball nor can we tell with certainty future financials, as President, it would not be ethically responsible not to take precautions to mitigate monetary loss.

Keeping this in mind, our National Board of Directors met to discuss the possible financial obligation of the 2022 Annual Membership Meeting scheduled for San Antonio. After hours of discussion, and the realization that TREA is standing at an operational net loss, due to low fundraising and membership renewal income, and with the concern over a potential stock market loss, the board voted to hold the 2022 Membership meeting virtually.

TREA's current Bylaws & Standing Rules allow for virtual membership meetings and the result will be a cost savings of over \$10K. We thank you for your continued support in making TREA: The Enlisted Association the paramount organization supporting ALL ENLISTED!!

TREA GIVES - OUR NEW BENEVOLENT PROGRAM

I am so excited to be the driving force behind this program and the good that it is doing and the plans that we have for the future. It is important that we understand and recognize the societal shift that is moving away from member-based organizations and more towards entities that provide a service or support for others. As veterans, we all understand and respect that we have to take care of each other. From the battlefields of the first war, through the shifts and changes of every branch of the service, down through today – those who served/serve are family; and family take care of each other. Years may have passed and the military may not resemble what it did all those years ago, but there are men and women who bravely served and fought for our country and your freedom and these great 'soldiers' should not and cannot be forgotten. For many, the military was a way of life – a lifelong dedication. For some it was a stepping-stone to something else, for some it was the end of life as they knew it. Wounds and scars, both seen and

unseen have wreaked havoc on and changed the course of life for many, many servicemembers and their families. Those that have come through their service time with great stories and memories and the ability to lead a normal, productive life are the lucky ones. Not all are so lucky and that is why we created this program. It was created out of the desire to help our brothers and sisters in arms - without judgement. We served together, now we need to help together.

Now that I have shared a little bit about how and why we started the TREA GIVES program, let me tell you what it does. It is not as simple as it sounds; as this program is multi-facetted in that it provides support for a multitude of needs.

First, we provide financial assistance. This does not mean that we are set up to keep someone in the lap of luxury, what we do is provide funds for those truly experiencing an emergency financial situation. This includes rent, utilities, clothing, food and emergency travel and shelter. Let me tell you about a few veterans (and their families) that we have helped so far under this category. There was a husband/wife family, both veterans. The wife's sister passed unexpectedly and she was unable to afford the trip back east to attend the funeral. She could not leave her husband, as she was his caregiver. Airfare and hotel for the two of them was not something that was budgeted for. We were able to provide the resources for two airline tickets that enabled them to fly back to the East Coast to be with family and to attend the services for her sister. Another example is a veteran and his wife, who were doing well, and then thanks to COVID, their adult daughter lost her job and overnight she moved in with her two children. These two veterans, who had no need to seek financial assistance previously, were now faced with additional expenses that they could not manage. We were able to pay their rent for two months, allowing them the breathing space that they needed to formulate a plan on how they were going to manage moving forward. The last story that I want to share, was shared in the Summer issue of The VOICE magazine. It was about a young active duty soldier who was PCSing with his family cross-country to his new duty station when his moving van, with all the family belongings was stolen. Can you imagine the emotional stress, not to mention the complete financial devastation, of having to replace everything that you own? We were there immediately with funds to help them rebuild, from the ground up. It was as much as a blessing to us as it was to the soldier and his family.

We have learned through this program that even the best made plans can be thrown off course through no personal fault, and the end results can be devastating. This is never more true than the last two years has shown us with COVID. Enlisted families are more vulnerable as they are usually forced to make ends meet with fewer resources than their civilian counterparts do. This is where we, TREA: The Enlisted Association can really make a difference and give a veteran/family a chance. Please consider donating to this program.



WASHINGTON UPDATE

Bill McCabe, Director of Legislative Affairs and Communications

As this is the last issue of The VOICE magazine for this year, I wanted to take the opportunity to review the many interactions with the U.S. Congress, the White House, the U.S. Department of Veterans Affairs, the Defense Health Agency, and the Veterans Service Organization (VSO) community, where TREA remained out front in our legislative efforts for servicemembers, veterans, and their families.

CEREMONIAL EVENTS

This year, TREA has been involved in many great legislative and ceremonial efforts in Washington, both virtually and in-person for the first time in over a year due to the COVID-19 pandemic. Events included the 2021 Memorial Day Ceremony at Arlington National Cemetery, where TREA's National President, Justin Jump, was able to represent TREA before President Biden, Defense Secretary Lloyd Austin, and members of the Veteran and Military Service Organization community. In addition, President Jump was proud to participate in another in-person ceremony commemorating the 73rd Anniversary of the Women's Armed Service Integration Act. He joined President CW5 Phyllis Wilson, OptumServe CEO and 43rd United States Army Surgeon General LTG Patricia Horoho, Acting Assistant Under Secretary for Health for Support with the Veterans Health Administration Ms. Deborah Kramer, and Congresswoman Julia Brownley.

OFFICIAL APPOINTMENTS

While still in process, Washington has begun to settle in, to include many official appointments in the Biden Administration and new leadership in the U.S. Congress. Most notably, TREA has welcomed and held meetings with Mr. Denis McDonough as Secretary of the U.S. Department of Veterans Affairs, Senators Jon Tester and Jerry Moran as Chairman and Ranking Members of the Senate Committee on Veterans Affairs, and Congressmen Mark Takano and Mike Bost as Chairman and Ranking Members of the House Committee on Veterans Affairs. In addition, TREA recently met with the Veterans Health Administration's Acting Undersecretary, Dr. Steven Lieberman.

U.S. CONGRESS LEGISLATIVE ACCOMPLISHMENTS

In addition to analyzing sensitive issues, providing documentation for decisions and developing position papers on critical issues, TREA successfully secured several legislative and regulatory wins in a short time frame. Through our efforts, TREA has attended numerous virtual House and Senate Veterans Affairs and Armed Services Committee hearings and participated in meetings and phone calls with Committee officials and their staff on issues of importance to veterans, active-duty servicemembers and retirees. We have also identified provisions on Agent Orange in the NDAA and lobbied all 435 members of the U.S. House and all 100 members of the U.S. Senate on issues of importance to TREA. As such, TREA has been able to maintain strong relationships within VA, DoD, as well as both Committees on the Hill and has secured several legislative accomplishments we are proud to report to you.

Toxic Exposures, Burn Pits, and Agent Orange

TREA continues to be a leading advocate on Toxic Exposures related legislation and was at the forefront during the historic introduction of two consequential healthcare bills in both the House and Senate. In the Senate, The Cost of War Act was introduced, with TREA shown as a lead advocate on the hill by Chairman Jon Tester's office. In addition, TREA has supported the introduction of The PACT Act in the U.S. House, which incorporates similar provisions as its Senate counterpart that TREA has worked on with the Toxic Exposures in the American Military (TEAM) Coalition for nearly two years. More on the bill below.

On December 7th, 1941, the U.S. Naval base at Pearl Harbor was attacked by Japanese warplanes. Four battleships sunk and eight were damaged, 188 planes were destroyed, and 2,403 Americans were killed — and almost half of those casualties occurred on the USS *Arizona*, which was hit four times by bombers and sank. The USS *Arizona* Memorial, in Hawaii, was created to remember the historic event, devastating tragedy, and brave U.S. service members. H.R. 1282 / S. 344, The Major Richard Star Act: TREA is proud to report that both H.R. 1282 and S. 344 were successfully re-introduced in both the U.S. House and Senate. Since then, TREA has been hard at work securing cosponsors in both chambers to ensure successful passage this year, with over 50 cosponsors in the Senate, and 110 cosponsors in the House. As you may know, this bipartisan legislation would finally provide combat injured veterans that were forced to medically retire with less than 20 years of military service their full benefits, meaning they would receive both their earned DoD Retirement Pay, and their earned VA Disability Pay, with no offset. This legislation is a very positive step in correcting the larger concurrent receipt issue.

Mental Health and Suicide Prevention

H.R. 1448 / S. 613, The PAWS For Veterans Therapy Act: Since the bills were introduced earlier this year, TREA was a leading advocate on successfully passing and signing the PAWS Act into law, which was made official in August. This legislation is a big win for veterans who are suffering from the invisible wounds of war who wish to seek scientifically proven alternatives of treatments, such as for PTSD, at the U.S. Department of Veterans Affairs. Here is a quote from TREA that was published in several press releases and media outlets in celebration of the bill: "Now more than ever, veterans suffering from invisible wounds of war need access to trained service dogs which have been scientifically proven to help alleviate symptoms of post-traumatic stress, traumatic brain injuries, and military sexual trauma" said Bill McCabe, Director of Legislative Affairs at The Enlisted Association. "We thank President Biden and Members of the House and Senate for recognizing veterans need every possible option when seeking mental health treatments, and look forward to working with the Department of Veterans Affairs to implement this important program." S. 1467, The VA Medicinal Cannabis Research Act of 2021 – In order to diversify our efforts, TREA has officially supported research to direct the Secretary of Veterans Affairs to carry out a series of clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder. TREA strongly supports alternative treatment options to augment traditional methods, giving veterans every option possible when confronting the debilitating effects of PTSD and injuries from their military service.

Military Families

S. 781, The Elaine M. Checketts Military Families Act: On April 21st, TREA sent an official letter of support and press release endorsement to Chairmen Jack Reed and Adam Smith, and Ranking Members Jim Inhofe and Mike Rogers of the U.S. House and Senate Armed Services Committees requesting that S. 781 be included in the FY22 National Defense Authorization Act (NDAA). Using my connection with their offices, I was able to get TREA's National President Justin Jump quoted in their press release. COMMUNICATIONS

TREA now has a very robust and proactive communications system comprised of social media accounts, e-newsletters, press releases, and of course, The VOICE.

In order to keep TREA in the spotlight, TREA has successfully secured mentions of our efforts in 29 press releases from 7 different U.S. Senators and 5 U.S. Congressmen in 2021. In addition to conventional methods, TREA's social media presence on Facebook, Twitter, and LinkedIn have increased exponentially. Utilizing these platforms, TREA is able to engage Members of Congress, reporters, celebrities, and other veteran and military service organizations in a more modern way, securing direct mentions of our organization and amplifying TREA's legislative efforts in Washington.

Finally, TREA has recently sent out 8 Call to Action requests to our members in effort to augment our legislative efforts in Washington. These efforts are critically important to ensure Congress feels the pressure and hears directly from you, as TREA members. These requests included support for the Major Richard Star Act, the PAWS Act, the Toxic Exposures in the American Military Act, and on behalf of Agent Orange presumptive conditions in the NDAA. When these requests hit your inbox, please consider replying and sending your tailored message to your respective representatives. Your voice matters!

We hope you all find this information helpful and comprehensive as to all the ways that TREA is working for and supporting enlisting service members in Washington. Those who served yesterday, those serving today, and those who will serve tomorrow.

BYLAWS & STANDING RULES CHANGES

The following proposed changes were reviewed by the Bylaws & Standing Rules Committee, the National Board of Directors and provided to the membership for final vote.

An independent, third-party company (Election America) managed the voting process. Their results, which were reviewed and approved by the Credentials Committee, were presented at the Annual Membership Meeting in San Diego. **ALL PROPOSED CHANGES WERE APPROVED.**

The result of the vote for the Annual Membership Meeting site for 2023 (TREA's 60th Anniversary) was overwhelmingly in favor of Las Vegas over a virtual meeting.

The membership also voting unanimously to approve the FY 2020 Audit as presented.

WHAT DO THESE CHANGES MEAN TO YOU? IMPORTANT CHANGES FOR THE MAGAZINE

In a nutshell, not much – most of them are internal processes that were just streamlined. The one change that does affect you, as a TREA member is Article XV (Publications). This change will result in approximately \$25K/year in savings by reducing the cost for printing and postage of the VOICE magazine by changing from a printed magazine that was mailed to every member, to an electronic distribution. This does NOT mean that you will not or cannot continue to receive the printed & mailed version. All you have to do is notify headquarters that you want to continue to receive the printed magazine. It's that simple.

To make it even easier, we are asking everyone who wishes to continue to receive the printed magazine to send their request to us through editor@trea.org. This e-mail is marked specifically for the magazine and will ensure that your request does not get lost in the hundreds of operational e-mails that we receive every day. If you have previously sent in a request to stay on the mail list, you DO NOT need to send in another one – we have a complete list of everyone who has communicated with us to continue to receive the printed magazine.

IMPORTANT – this is your last printed and mailed magazine (unless you notify us to keep you on the mail list). The next issue, the 2022 Winter issue, scheduled for February will be delivered to the e-mail address that we have on file. It is important that you update this information with us. An electronic version is and will continue to be available on our website.

We are excited about this change and believe that the shift to electronic distribution will provide better service, resources and information to our members. All links will be live and will be easily accessed with the click of the mouse. No more trying (and failing) to type in those LONG web links. A simple click will take you directly to articles, active legislative information, veteran resources, photos and e-mails. It really will make it easier for you to access all the important information that TREA is sharing. We are very active, and successful in our legislative efforts, being quoted in over 29 press releases and legislative articles in this year alone. You will now be able to read all of our successes by clicking on the links provided in the respective articles. No more searching and typing – just a simple click.





Applications were scored on the following: Grade Point Averages, Scholastic Achievement/Involvement (Valedictorian, Honor Roll, etc.), School Sponsored Extra-Curricular Activities (debate team, sports, clubs, JROTC, etc.), Non-School Sponsored Extra-Curricular Activities, to include community volunteer activities, (4-H state champion, Boy/Eagle scouts, Girl Scouts, volunteering at a local senior citizen's home, hospital or volunteering at a food bank, etc.), Work Experience and Written Essay. All applicants must be the child or grandchild of a TREA member. The child or grandchild of a TREA member who has passed is still eligible, provided that member was active at the time of his/her passing.

The Scholarship recipients received a total of \$18,500 for the 2021-2022 academic year. The 2022-2023 Scholarship Application will be posted on our website (www.trea.org) on January 1, 2022.



The Senior Citizens League – Special Stimulus for Social Security Recipients By Chairman Rick Delaney



TREA Senior Citizens League has an online petition and is lobbying Congress for a **special stimulus of \$1,400.00 for Social Security recipients only**. It's been in the news from cnbc.com to military.com!

Across the country household budgets of seniors and disabled **Social Security recipients** have taken a hammering by skyrocketing costs. The League has received thousands of emails from our supporters that tell us examples about their soaring costs. We've heard from people who have exhausted their retirement savings, who have started eating just one meal a day, cutting their pills in half, and many more examples of the toll inflation has taken on them this year.

One sign of how high inflation has gotten is the projection for the 2022 Cost of Living Adjustment (COLA). It's projected to be one of the highest COLAs since 1983. Gasoline is up almost 50% from the summer of 2020. And, new or used cars/trucks, if you can find one, is up over 40%. And, let's face it, no matter what the COLA is for 2022, it's going to be eaten up by Medicare Part B premium increases.
