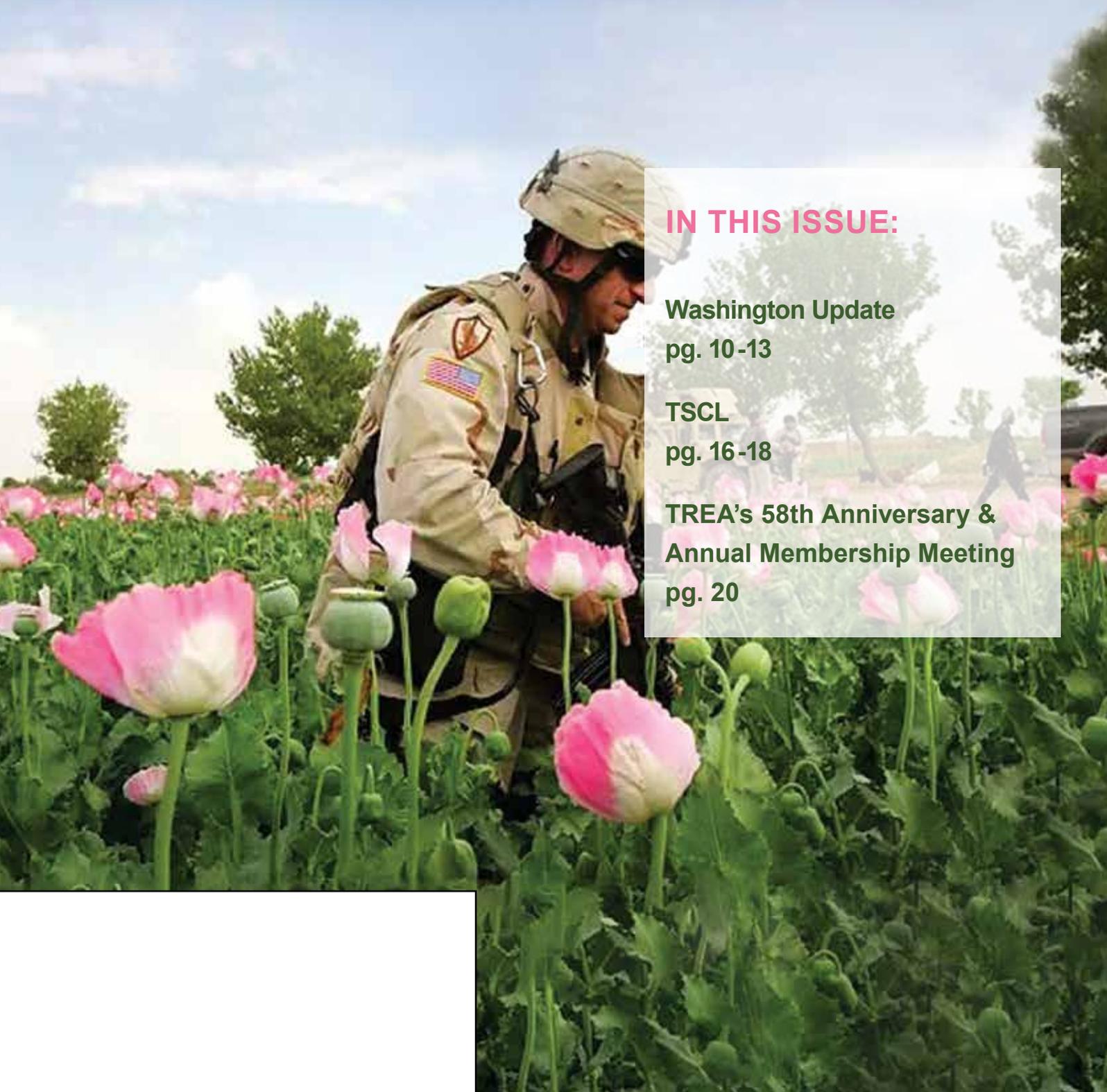

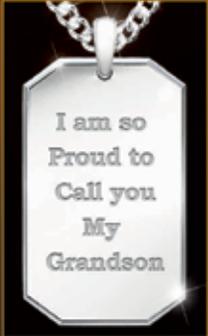

WASHINGTON UPDATE

Bill McCabe, Director of Legislative Affairs and Communications



TREA Members,

I want to introduce myself as my role has recently changed. My name is Bill McCabe, and I currently serve as TREA's Director of Legislative Affairs and Communications here in Washington, D.C. Previously, I had served as your Deputy Director. In addition to working as your advocate, I also serve as an enlisted soldier in the U.S. Army National Guard. My appointment as your chief advocate in Washington is truly an honor, and I look forward to getting to know each of you as we enter the 117th Congress.

Now that we have been briefly acquainted, it's time to show you what I have been doing on your behalf on Capitol Hill, at the White House, VA, and DoD. As you can imagine, Washington has been in what we call a "wash cycle" since the inauguration on January 20th. Members of Congress and their staff have turned over at a relatively high rate, official appointments in the new Administration have started to trickle in, and legislative priorities have begun to manifest. As the dust begins to settle entering the 117th Congress, I wanted to provide you with an overview of some of the legislative and regulatory accomplishments that TREA has been involved in. Below you will find five major priorities that TREA Members have strongly supported, both in written email and over the phone, along with a brief rundown of what we have already accomplished in the first three months of 2021.

Service Member and Veteran Caregivers

Through our work with Rep. Richard Hudson (R-NC) and Rep. Kathleen Rice (D-NY), TREA successfully secured the introduction of H.R.110 - Care for the Veteran Caregiver Act, which requires VA to extend stipend payments and CHAMPVA eligibility for caregivers, eliminates unnecessary and redundant re-evaluation requirements, and standardizes the initial and annual eligibility evaluation process.

Concurrent Receipt

(Fixing VA Disability Pay + DOD Retirement Pay Offset)

TREA was successful in securing the introduction of the Major Richard Star Act, where I was able to get TREA quoted in every press release as leading advocate on the issue. The bipartisan legislation would finally provide combat-injured veterans that were forced to medically retire with less than 20 years of military service their full benefits, meaning they would receive both their earned DoD Retirement Pay, and their earned VA Disability Pay, with no offset.

Toxic Exposures, Burn Pits, and Agent Orange

As you know, health care eligibility and service-connected claims for those exposed to toxic chemicals and Agent

Orange during their military service are critical and time sensitive. As such, TREA continues to be a leading advocate on Toxic Exposures and was at the forefront during the re-introduction of the TEAM Act (S. 927) on March 23rd where TREA was invited to speak at Senator Tillis and Senator Hassan's press conference and quoted in every major press release. In addition, TREA will maintain efforts to have VA and DOD be more proactive in addressing these issues once and for all, especially as future conflicts arise.

TRICARE Benefits

Recent legislation aimed to reform the Military Health System has unintentionally eroded the value of pharmacy benefits and poses a threat to Military Treatment Facilities, access to pharmacies, and zero copay prescription medications. As such, I have begun working with the Defense Health Agency to protect pharmacy benefits, access to Military Treatment Facilities, and to achieve flexibility in TRICARE pharmacy copays for TREA Members.

Suicide Prevention

During my role as Deputy Director, I ensured TREA was recognized for our work on passing two major bills to reduce veteran suicide, most notably S. 785, the Commander John Scott Hannon Act. This year, I will continue TREA's advocacy for suicide and mental health initiatives and remain as an Ambassador to the PREVENTS Task Force, a bipartisan interagency effort established by the White House in conjunction with VA to raise awareness and change the stigma surrounding the national tragedy of suicide. In addition, with my consistent push, TREA is now a leading advocate on HR 1022 and HR 1448, The PAWS Act, which is legislation aimed at pairing service dogs with veterans suffering from physical and mental wounds of war, such as PTSD.

Call to Action Emails

First, I want to thank you all for your willingness to participate in our Call-to-Action requests. I also include a sample message that you may edit accordingly based on your personal opinions and experience with the issues. We all need to participate in the process – our numbers truly count!

TREA RAISES AWARENESS ON HEARING LOSS

Connecting Veterans with Free Telephone Captioning Services

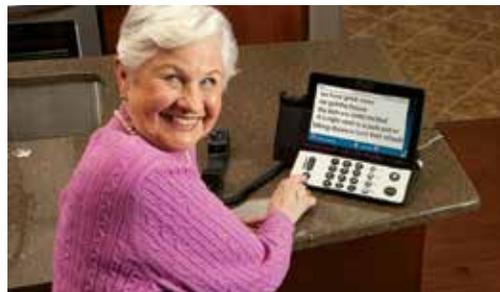

As a proud member of the Clear2Connect Coalition, TREA has been raising awareness and educating lawmakers about the critical importance of quality, accurate Captioned Telephone Services (CTS). Veterans and others with hearing loss can receive free assistive technology for captioned telephone service from participating providers of the Federal Communications Commission (FCC) on their home phones, mobile phones and other communication apps. Real-time transcriptions of communication are a vital service for those who rely on their phones to stay connected with family and friends, and to communicate with health care professionals and emergency responders.

Veterans of all ages can benefit from captioned telephone service, as they are disproportionately affected by hearing loss. Hearing loss is not just due to degeneration from aging; **Veterans are 30% more likely than non-Veterans to have a hearing impairment, which is the fastest growing post war disability.** Currently, nearly 3 million veterans with hearing loss and tinnitus receive benefits from the U.S. Department of Veterans Affairs, with over 600,000 veterans of the Iraq and Afghanistan wars alone returning home with permanent hearing loss.

What is Captioned Telephone Service?

Captioned telephone service enables people with hearing loss to speak during a phone call and then read the other person's response in real time as transcriptions appear directly on their telephone or an app. This service is known as Internet Protocol Captioned Telephone Service (IP CTS), and it uses a combination of automatic speech recognition (ASR) technology and skilled transcribers, or ASR technology.



Who is Eligible for Captioned Telephone Service and What does it Cost?

This technology service is free to service members and Veterans, including their loved ones and anyone with hearing loss. Vietnam Veteran and captioned telephone user Ronald Drach says this service is “invaluable” and “life-changing.” Vietnam Veteran Robert Richardson agrees, saying, “This technology, above all others, has had a major impact on my quality of life. I’d say it’s a lifesaver. I use it to communicate with my children, and I use it to communicate with my friends and my doctors and other healthcare providers. I use it to stay engaged in my community. I may be retired from work, but not from life.”

How to Get Free Captioned Telephone Service

Several providers offer captioned telephone service. When registering for this service with providers, the FCC requires individuals to self-certify that they have hearing loss necessitating telephone captioning. Some providers may require professional certification from a physician, audiologist or other hearing-health professional.

As a proud member of The Clear2Connect Coalition which is comprised of Disability and Veterans Service Organizations, TREA advocates on behalf of the deaf and hard of hearing communities to have access to quality, accurate communication technology.

THE SENIOR CITIZENS LEAGUE – DID YOU KNOW?

Did you know The Senior Citizens League scrutinizes specific senior related cost increases each year? An eye - popping new list compiled by The Senior Citizens League (TSCL) indicates that by late 2020, price increases for many of the expenditures of older Americans far outstripped the modest 1.3 percent cost of living adjustment (COLA) boost that Social Security recipients started receiving this year. This list is a snapshot of how COVID-19 affected prices of certain items by the end of November 2020. There are surprising price aberrations that we haven't seen before. Never in my wildest dreams would I have thought that toilet paper and disinfecting wipes could wind up on our annual list of fastest growing retiree costs.

The far greater worry, however, is a sharp increase in almost every source of quality protein — including meat, poultry, and even canned tuna. With many meat price increases in the double digits, we are highly concerned that older households may not be getting adequate supplies of protein in their diets. This was a nationwide problem prior to the pandemic, and the problem has been exacerbated by shortages and disruptions during the pandemic.

While appliances and used vehicles are generally only purchased occasionally, 2020 was not a good time to be shopping for a new washer or used car. 4. We share information. We have an active Legislative Outreach that provides TREA members with important legislative information. Our quarterly magazine, The VOICE, (a perk of membership) outlines our legislative actions and provides important congressional updates to our members.

5. We make a difference. TREA has a dedicated philanthropy belief and has created a strong benevolent program that provides financial assistance to past and current enlisted veterans and their families in need. We also have a large-scale scholarship program that awards over \$17K each year to the children and grandchildren of members.

Did you know that the spouses of veterans are eligible for full regular membership in TREA? This change was incorporated two years ago to ensure that TREA supports and advocates for the full veteran family.
