tary sexual trauma. With the this innovative program allows the

majority of dogs being rescues, this innovative program allows the K9/Warrior team to build an unwavering bond that facilitates their collective healing and recovery. This treatment method is backed by scientific research from University of Arizona's OHAIRE Lab demonstrating Service Dogs' ability to help mitigate their Veteran's symptoms of PTSD while simultaneously restoring their confidence and independence. The President's Fiscal Year 2025 Budget

On March 7, 2024, President Joe Biden delivered his final State of the Union Address of his 2020-2024 term to a joint session of Congress amid delayed appropriations from FY 2024. The following week on March 11, 2024, the Biden-Harris Administration released the President's Budget for FY 2025. As the President high-

lighted in his speech, the budget proposes critical resources to help the U.S. Department of Veterans Affairs (VA) continue providing more care and more benefits to Veterans than in previous years.

As a key pillar of his Unity Agenda, the President's Budget requests \$369.3 billion for VA care and services, a \$33 billion (+10%) increase above the FY 2024 Budget estimate level, including a discretionary funding request of \$134.0 billion and a mandatory request of \$235.3 billion. Most notably, the proposal includes \$24.5 billion from the Cost of War Toxic Exposures Fund (TEF), for a total increase of \$41.8 billion (21.6%) above fiscal year 2024.

At VA, the proposed Budget will aim to expand health care and benefits for Veterans who were exposed to toxins and other hazards while serving our country, support the delivery of health care for Veterans across America, prioritize mental health care and suicide prevention for Veterans, support health care for women Veterans, bolster efforts to end Veteran homelessness, and invest in claims processing and benefits delivery for Veterans.

As the FY 2025 appropriations process begins, TREA will continue to engage the White House, VA, and Congress to ensure your priorities are heard, included, and properly funded.

118th Congress

As the 118th Congress enters its final calendar year ahead of a Presidential election, Members of Congress and their staff are still scrambling to fund the government by way of Continuing Resolutions and, at times, "handshake deals." The recent deal funds the government through September 30, 2024, and includes roughly \$1.1 trillion in funding for the Departments of Defense, Homeland Security, State, Treasury, Labor, Health and Human Services, and Education. Despite their "kicking the can down the road" approach to FY 2024 funding, TREA has urged and will continue to push Congress to fully fund the government in FY 2024 before beginning the FY 2025 appropriations process.

The Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act

Since August of 2024, the House and Senate Committees on Veterans' Affairs have agreed on text for an "omnibus" spending package that includes a host of TREA's priorities, known as "The Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act." This comprehensive package includes a number of bipartisan, TREA backed proposals that would enhance and reform the delivery of benefits and care at VA, including:

- The Elizabeth Dole Home Care Act
- The HOME Act
- VA Community Care Program Enhancements
- The Revised Electronic Healthcare Record Modernization Reset Act
- Funding the VET-TEC Education Program
- Modernizing USERRA Protections
- Cutting "Red-Tape" for Student Veterans Using The G.I. Bill
- Funding a Grant Program for County Veteran Service Officers
- Modernizing DBQ Act

The total score or "cost" the Congressional Budget Office has given the package is over \$11 billion, which has led to further negotiations to find offsets. TREA will continue to monitor the progress of the legislative package and urge Congress to pass it without delay.

The Major Richard Star Act

On Tuesday, March 5, 2024, TREA proudly stood with members of The Military Coalition on Capitol Hill in support of S. 344 / H.R. 1282, The Major Richard Star Act, to urge Congress to include the bill in the baseline text of the FY25 NDAA.

Under current law, servicemembers who are medically retired due to combat-related injuries before reaching 20 years of service are prevented from collecting both their service earned retirement pay and VA disability compensation. These two benefits, established by Congress for entirely different reasons, are nonetheless subject to a statutory offset. The Major Richard Star Act will authorize concurrent receipt

of DoD retired pay, for years of service, and VA disability compensation for injuries incurred in service. This legislation is another small step in correcting a larger concurrent receipt problem.

Since its re-introduction in the 118th Congress, TREA has worked hard to ensure the Major Richard Star Act has gained support on Capitol Hill, aiding efforts to secure 73 cosponsors in the Senate, and 326 cosponsors in the House. Despite the majority of both chambers supporting this critical legislation, we need your help to get the bill across the finish line.

TREA is requesting that Members of Congress ensure S. 344 / H.R. 1282 - The Major Richard Star Act, will be incorporated into the FY 2025 National Defense Authorization Act (NDAA). NATIONAL CEMETERY BURIAL ELIGIBILITY IN THE 21ST CENTURY

On September 1, 1973, VA became steward of the 112-year-old National Cemetery System, the forerunner of the National Cemetery Administration (NCA). Today, NCA (www.cem.va.gov) manages 155 national cemeteries in the United States and provides grant-funding to 122 state, territory and tribal Veterans cemeteries. Over 4.1 million Veterans of every conflict—from the Revolutionary War to the wars in Iraq and Afghanistan—are honored by burial in these cemeteries.

NCA has assisted millions of Veterans and their families in scheduling and arranging for burial at national cemeteries for themselves and their spouses. In 2016, NCA developed a Pre-Need Eligibility application to assist families with burial planning. No longer do Veterans or spouses need to wait until the time of death to find out if they are eligible for burial in a national cemetery or for memorial benefits such as a headstone, flat marker, or bronze medallion for use in private cemeteries.

In FY 2023, 55,374 Pre-Need applications were approved. There were 139,360 interments in national cemeteries and 33,556 headstones and markers provided for burial in private cemeteries. Pre-Need applications require the Veteran's social security number, date/place of birth, military status and service history such as service dates, discharge character, and rank—information commonly found on the DD214 or other separation documents. If you do not have discharge documents, NCA staff will help obtain the information needed to determine eligibility. Applicants can apply: online at www.va.gov/burials-memorials/pre-need-eligibility/, via mail or fax using this form www.va.gov/find-forms/about-form-40-10007/, or simply search for "NCA Pre Need" on the internet.

If you have questions about future burial needs for yourself or a living dependent of a Veteran, or you need assistance with the submitting an application, please call 800-535-1117 and press 4. NCA's Scheduling Office is open Monday through Friday 8:00am to 7:30pm EST and Saturday 9:00am to 5:30pm EST except Thanksgiving, Christmas, and New Year's Day. BYLAWS AND STANDING RULES COMMITTEE IS MEETING SOON

Your Bylaws and Standing Rules Committee will soon be meeting to review and evaluate proposed changes to our National Rules. These rules affect all members of our organization. The review process is as follows. TREA members propose changes which are submitted to TREAHQ@trea.org or me, the committee chair at 1stvice@trea.org. The Chairman circulates the proposals to the committee, and we meet soon after to discuss proposed changes. The changes are reviewed for consistency with existing rules and then approved or rejected by the committee. Both approved and rejected proposals are submitted to your National Board of Directors at mid-term. If your board approves the change, it is forwarded to you, the membership, for final approval through the voting system. All members have to opportunity to approve the changes, which once accepted by you the membership, become the law of the organization.

These changes should be compared against the chapter bylaws to see if any changes are required there.

If you have changes to submit, get them in as soon as possible. Why? Because when they reach us determine the votes needed to pass! Article 14 (Amendment of Bylaws and Rules), section 1, contains those dates. The first date, March 31, has already passed.

THE IMPACT OF PROPOSED COLA CUTS ON OLDER AMERICANS, MILITARY RETIREES, AND VETERANS

TSCL's unwavering commitment to advocating for legislation that enhances benefits for older Americans is mirrored by our steadfast opposition to any proposals that seek to diminish these benefits.

Military retired pay is adjusted for inflation by law (10 U.S.C. §1401a). Congress hasn't changed the Cost-of-Living-Adjustment (COLA) formula since 1995. However, policymakers often discuss adjust-ing COLAs to lower costs and payments to retirees.

While COLA to VA disability benefit amounts usually occurred yearly, it was not guaranteed. Each year, Congress had to pass a new bill to increase benefits the following year, and the President had to sign it into law.

That changed last year with the passage of The Veterans Compensation Cost-of-Living-Adjustment (COLA) Act of 2023. The law directs the Department of Veterans Affairs to provide a COLA for Veteran's benefits equal to the COLA applied to Social Security benefits annually.

Over the past three decades, TSCL has seen and doggedly opposed numerous legislative bills that would cut benefits for retirees and veterans. Almost all these plans shared one key element: cuts to the COLA.

The most frequently proposed COLA reduction proposal is transitioning the inflation index to a slower-growing 'chained' Consumer Price Index (CPI). This change could significantly impact the COLA system, potentially leading to fewer or smaller benefit increases for retirees and veterans.

The Chained CPI, unlike the CPI-W, incorporates a crucial difference: substitution. It accounts for the likelihood of consumers switching to cheaper alternatives if prices rise significantly. For example, consumers will switch to margarine if butter prices rise significantly. If the cost of brand-name cereals rises significantly, consumers will switch to store brands, etc.





A recent TSCL analysis compared the COLA increases from 2015 to 2024 with hypothetical increases using the Chained CPI. For instance, a \$1,294 starting monthly benefit in 2014 would reach \$1,692.20 in 2024 under current rules. However, with the Chained CPI, it would only amount to \$1,653.10, a difference of about \$39 per month and a total income reduction of about \$1,808 since 2015. This analysis emphasizes the critical impact of our advocacy work.

The difference may seem minor initially, but the impact accumulates significantly over time due to compounding.

TSCL remains dedicated to advocating for the protection and enhancement of cost-of-living adjustments (COLA) for senior citizens, military retirees, and veterans.
