IT STARTS WITH A WHY Walt Coley, 3rd Vice President & Chairman of the 5-Year Plan Committee



I survived my first mid-term! I can honestly share with you that the last six months have been a challenging learning experience. If I hadn't been prepared by a life in government and business at understanding how systems work, how to ask questions, how to analyze processes, and patience, I would have pulled my hair out, I still almost did the last thing, then I stopped and remembered one word: WHY.

Why did TREA exist?

TREA exists as the Voice of the Enlisted, formed by retired senior NCOs to work for the well-being of the enlisted force and their families; that's the WHY. So, with that and what was presented in the 5-year plan, we determined there were several things

that needed doing, but 2 things that needed doing most of all.

• We need to align TREA with who we are today and prepare it for the future. All levels of What We Do must agree with Who We Are. That means we must go through our Standing Rules and Bylaws, taking a hard look at every line and concept – assuring they reflect our legacy as well as the present; while leaving room for the future. Public Relations and Marketing must reflect this, and we all need to get on board and sell it! Asking people ready to retire what they are concerned about gives them a WHY for joining us!

• Improve TREA's member interaction and communication. Modify TREA Bylaws and Standing Rules to recognize the vast majority of TREA members are Members at Large, don't attend convention, and have no voice in the organization's structure. Convention attendance is down and fewer members make decisions for all – even as membership continues to decline. Voting by mail for now will help. Providing Washington Updates from LAO lets members know what we fight for in D.C. will help too.

These two things, as well as publicizing things we are doing better, like providing information out through the Washington Update, with an eye toward adding state and local activity from our members conveys unity of purpose. It shows we have a Vision and a purpose, and our intention to keep the promise made by our founders, that United We Stand is more than words... it's Who We Are.

TREA MEMBERS YOU CAN ATTEND - CAMP LEJEUNE, COMMUNITY ASSISTANCE PANEL MEETING, SEPTEMBER 13-14, 2019

On Friday and Saturday, Sept. 13–14, 2019, the Agency for Toxic Substances and Disease Registry (ATSDR) will host a Camp Lejeune Community Assistance Panel (CAP) meeting at the Hilton Crystal City at Washington Reagan National Airport.

The two-day event features a CAP business meeting on Friday from 5:00–8:00 pm., and a public forum on Saturday from 9:00 a.m.–1:00 p.m. The Saturday public forum is an opportunity for TREA members to participate in the discussion directly with ATSDR staff and CAP members. You can attend this part of the meeting in person or online. You must register at https://www.atsdr.cdc.gov/sites/lejeune/capregistration.asp to attend in person. Online participation does not require registration.

ATSDR is involved in research regarding water-contamination issues discovered in 1982 at Camp Lejeune, North Carolina. ATSDR created the CAP to represent the affected community of Marines (and other military service members) and their families stationed between 1953 and 1987 at Camp Lejeune and to provide input on ATSDR's public health activities.



WASHINGTON UPDATE Ken Greenberg, Director of Veterans and Military Policy



TREA is pleased to provide an update on legislative actions in the 116th Congress. One significant milestone, H.R. 299, the Navy Blue Water Vietnam Veterans Act of 2019 was signed into law on June 25, 2019. Other proposals have passed the House and are awaiting action by the Senate. Some bills are being modified after being the subject of Congressional hearings.

TREA continues to work hard to see that the benefit earned by veterans, service members, as well as Guard and Reserve are protected. We cannot do it alone. Members should contact House and Senate members and ask them to support the bills highlighted in this article.

TREA's website **www.trea.org** contains additional details on legislation and policies related to DOD and VA. Members are directed to use the links on the TREA home page to access this important information. Examples include MISSION Act effective June 6, 2019, and Education Press Conference on June 13, 2019.

Navy Blue Water Bill, H.R. 299, signed as Public Law 116-23 on June 25, 2019. The wait is finally over!! The Senate cleared the bill on June 12, after the House passed the bill on May 14, to expand disability compensation for Vietnam-era veterans who have been denied benefits for illnesses linked to Agent Orange exposure for decades. The bill extends disability compensation benefits to Navy veterans who served on ships off the coast of southeast Asia. VA announced that claims will begin to be processed on January 1, 2020. TREA continues to push VA to begin processing claims ASAP.' Go to www.trea.org and click on legislative for the 5/16/19 full report.

TREA Supported Retired Pay Issues

Concurrent Receipt H.R. 333 and H.R. 303: TREA has long believed that retired pay and VA service-connected disability compensation are different benefits and earned for different reasons. Military retired pay is earned by 20 or more years of service while service-connected disability compensation is a benefit used to supplant a veteran's lost earnings. Military retirees who are less than 50% service-connected are required to offset their retired pay with the amount of VA disability received. TREA continues to work with Members to eliminate the offset and permit concurrent receipt of retired military benefits and VA disability benefits.

Reserve Retired Pay Sense of Congress: TREA has heard from members concerning delays in receiving reserve retired pay. TREA is urging Congress to call on the service branches to address the delays and provide retired pay to reservists in a timely manner.

H.R. 2952 Montgomery GI Bill Parity Act of 2019: The bill permits Reservists to supplement Tuition Assistance with their Montgomery-GI Bill benefits. While permitted for active-duty service members, this strengthens education benefits for Reservists and provides greater flexibility to use their benefits.

H.R. 2953 Aviation Incentive Pay Parity Act: The bill permits the military branches to pay aviators in the Guard and Reserves the same Aviation Incentive Pay received by active duty pilots. It responds to a widespread and critical shortage of pilots in the armed services.

H.R. 2954 National Guard and Reserves Retirement Pay Parity Act: This bill provides retirement benefit parity for Reservists deployed on 12304b orders. They will receive a reduction in the age at which retirement pay can eventually be received, as already exists for Reservists mobilized on other types of orders.

SBP/DIC Offset Update - More Members Cosponsor bills than ever before

TREA continues to support efforts and urges Congress to pass legislation to allow military retiree survivors to receive full Survivor Benefit Plan benefits. H.R. 553 (352 cosponsors) in the House and S. 622 (75 cosponsors) in the Senate would end the deduction of Survivor Benefit Plan (SBP) annuities from Dependency and Indemnity Compensation (DIC) paid to survivors of fallen service members, also known as the "widows tax." (now included in House version of NDAA)

The SBP law includes a dollar-for-dollar offset of DIC from SBP, called the SBP/DIC offset, for surviving spouses of retired service members who voluntarily participated in the insurance annuity program, paid premiums, and then died of a service-connected issue. Post-9/11 active duty surviving spouses also are impacted. The offset affects more than 60,000 military surviving spouses.

TREA Members we need your help - Contact your Congressman/Senators - urge them to support these important retired pay and SBP/DIC proposals.

The House of Representatives on May 21, 2019 passed nine pieces of legislation concerning the Department of Veterans Affairs, five of which focus specifically on suicide prevention.

- H.R. 2359, Whole Veteran Act: VA to report to Congress on advancing the Whole Health model of providing care.
- H.R. 1812, Vet Center Eligibility Expansion Act: expand eligibility for Vet Center services to veterans of the reserve components who were called up in response to disaster or humanitarian mis sions or drug interdiction.
- H.R. 1947, To amend title 38, United States Code, to exempt transfers of funds from Federal agencies to the Department of Veterans Affairs for nonprofit corporations established under subchapter IV of chapter 73 of such title from certain provisions of the Economy Act.
- H.R. 2326, Navy Seal Chief Petty Officer William Bill Mulder (Ret.) Transition Improvement Act of 2019: improve the transition services provided to service members as they prepare to leave the military.
- H.R. 2333, Support for Suicide Prevention Coordinators Act: assess the responsibilities, workload and vacancy rates of the VA's suicide prevention coordinators.
- H.R. 2340, FIGHT Veteran Suicide Act: VA to notify Congress of any suicide or attempted suicide in a VA facility.

All nine bills were referred to the Senate and TREA will continue to monitor their progress and provide updates as actions take place. For additional details on each bill go to www.trea.org and click on leg-islative for 5/20/19 full report.

TREA Education Priorities - Reauthorization of 2019 Higher Education Act (HEA) visit www.trea.org to view the press conference on June 13, 2019.

Close the 90/10 Loophole: This rule prohibits for-profit schools from receiving more than 90 percent of their revenues from federal financial aid. The loophole is that VA/DoD education funds do not count as federal funds, instead counting as private dollars. By leaving this loophole open, for-profit schools and low-quality institutions see veterans as nothing more than "dollar signs in uniform."

Enhance Borrower's Defense Regulations: Protect students from being defrauded by colleges and left with nothing to show for it - no degree, piles of student loans, and no GI Bill. Defrauded students deserve the loan protection they are entitled to under Borrower Defense. 78 percent of Americans support loan forgiveness for defrauded students.

H.R. 3369, Defending All Veterans in Education (DAVIE) Act accomplishes the above and is supported by TREA.

TREA joins Toxic Exposure in the American Military (TEAM) Working Group

In June, TREA joined a new coalition of 13 VSOs/MSOs to address the issue of toxic exposure. The Toxic Exposures in the American Military (TEAM) coalition will research currently available data to develop resources and advocate for additional exposure treatment for veterans and active duty service members. There are more than 165,000 veterans enrolled in the VA's Burn Pit Registry – all of whom served on or after 9/11 and were deployed to a base or station where open burn pits were used. The goal of TEAM is to gather and share information, develop legislation, and combine resources to encourage Congress to pass meaningful toxic exposure legislation.

TREA supports H.R. 633/S. 191 - Burn Pits Accountability Act.

Toxic Exposure: Recognition of Illnesses Caused by Hazardous Warfare Agents. DOD and the services are to evaluate whether each member of the Armed Forces has been (1) based or stationed where an open air burn pit was used to dispose of waste, or (2) exposed to toxic airborne chemicals. Members located where an open burn pit was used or exposed to toxic airborne chemicals must be enrolled in the Airborne Hazards and Open Burn Pit Registry, unless the member opts for, not to enroll. The evaluations must be included in periodic health assessments, physical exams conducted immediately prior to separation from active duty, and deployment assessments. DOD must share the results of the evaluations with VA, (included in Senate version of NDAA).

TREA Supports H.R. 2617 – Occupational and Environmental Transparency Health (OATH) Act To amend title 10, U.S.C., to enhance recordkeeping with respect to exposure by members of the Armed Forces to certain occupational and environmental hazards while deployed. (included in Senate version of NDAA)

WASHINGTON UPDATE (CONT.)

The House passed H.R. 2500 on a vote of 220-197 on July 12th. TREA looks forward to resolving the differences by working with House and Senate Conferences.

Appropriations for DOD are included in H.R. 2740, that was passed by the House by a vote of 226-203 on June 19, 2019. The bill contains \$690.2 billion for Defense, a \$15.8 billion increase from 2019. Senate action is expected in July.

Appropriations for Military Construction and VA are included in H.R. 3055, that was passed by the House by a vote of 227-194 on June 25, 2019. The bill contains \$108.4 billion for Military Construction-VA, a \$10.4 billion increase from 2019. Senate action is expected in July.

MISSION Act effective June 6, 2019 -- What the changes mean to you.

VA health care options are expanding and TREA is sharing important information to keep you informed! These changes may provide you with the option to see private sector care providers, if you meet the eligibility criteria described below.

VA Health Care Eligibility

Veterans who have enrolled are eligible for care from VA hospitals based on a tier system or Priority group that looks at their service-connected injuries, income and other criteria. The Priority system was not changed by the Mission Act. Veterans do not need to take any action to remain enrolled. The MISSION Act provides additional options for care if you meet community care eligibility requirements.

VA Community Care Eligibility

VA Choice was the previous option and established rules around who could receive care outside the VA hospital. Choice expired on June 6, 2019. The MISSION Act is the new community care program and is updated to include new eligibility standards. You can see a community-based doctor if:

- Care is not available within the new access standards, which cap wait times at 20 days for primary care and 28 days for specialty care and drive times for 30 minutes for primary care and 60 minutes for specialists;
- Necessary care is not provided by the VA at a nearby facility;
- You live in a designated state or territory where VA is not full service like Hawaii, Alaska, New Hampshire, Guam, American Samoa, Northern Mariana Islands and the U.S. Virgin Islands;
- You are grandfathered into the old Choice rules, and paid for by VA which allowed for community-based care if you lived 40 miles or more from the nearest VA hospital;
- VA doctors believe community-based care is best for you. (the best interest of the veteran);
- VA has designated the type of care you need as not meeting standards;

VA Urgent and Walk-In Care

Starting June 6, veterans who have received care from the VA in the last 24 months can get care at some community-based urgent care facilities. Very important fact - urgent care facilities MUST be within VA's Network or contract to be covered.

As a seasoned member of the TREA National Board of Directors, I have continued to make it my priority to have clear understanding and insight to not only the TREA finances, but the Memorial Foundation and The Senior Citizens League (TSCL) as well. I can confirm that the financial struggle is real and that it continues to be a primary focus. This concern is not isolated to TREA. All VSO's throughout the country are facing the same dilemma. It is not my intent to always bring out the negative, but the facts are the facts and real change cannot happen unless real information is shared and understood.

Membership Numbers: Our membership is our lifeline and we should all be aware of the trending decline in numbers. As of this writing, our active membership is cur-

rently at 26,796 a decrease in 1,956 members since the same time last year. While this may seem bad at first glance, it is much better than the 2017 to 2018 loss of 4,648. Out of the 26,796 current members that we have, 16,567 are lifetime members.

We have 6,492 members whose membership with us will expire within the next 12 months. We have had 964 members renew with us since June of 2018. While it is important to reach out and bring in new members, it is just as important to keep our current members. This is something that we have committed our efforts to by bringing the renewal program in-house. This allows for a more personal approach that members can expect and want. It will also give us the ability to use e-mail as a source of communications, saving the cost of paper, envelops printing, stamps and time. In addition to renewing current members, we have to look at life....and death. Unfortunately, in the last 12 months, we have lost 791 members due to their passing. This is a very real issue and one that we cannot change. It means that we have to work harder to bring in new members just to stay even. Since January 2019, we have signed up 89 new members.

Acquisition Program: The Acquisition Program went into effect in late June. The purpose of this program is to bring in new members to the organization. It's that simple – or it should be. The problem, as we know and appreciate, is the fact that obtaining personal information on active duty or retired military personnel is not an easy task. That information is kept confidential and private by government agencies. This creates a road block before we even get started. That said, we are not giving up, TREA's mission is real and vital because we ARE THE VOICE OF THE ENLISTED. Our efforts to bring in new members can be greatly increased if each and every one of you participates in the recruitment of at least one new member. Imagine how amazing that would be? (More about this new program on page 28)

TSCL Royalty Revenue: The royalty that TREA receives from TSCL continues to decline as they experience the same downward trend in fundraising as all other donor based organizations. Working together with the TSCL Board of Trustees, the TREA board agreed to reduce the trademark fee from 25% down to 18%. This should provide much needed financial relief for TSCL; however, it does come at a cost to TREA. The Trademark fee for the first Quarter of 2019 was \$23,750 – this is a \$8,402 increase from the 2018 1st quarter fee but an overall decrease of \$38,743 from just two years ago.

Convention: There has been much discussion surrounding this topic – views from all angles have been shared, dissected and pondered. The question remains: As a non-profit organization, are we utilizing our finances properly by continuing to host an annual convention for such a small invested group of attendees? My answer today would have to be – no – BUT, I think it is possible to find a way to hold an annual meeting that would continue to allow members to come together to discuss and make important decisions for TREA without obligating TREA to a large expense. Simply put, we must find a way to conduct proper business

while minimizing TREA's financial liability. TREA is; after all, a membership organization and we need to continue to respect and value that. The voices of ALL of our members are important. Are you engaged in TREA? If not, why? What can we do to change that? TREA has always been YOUR organization and as such, it requires your involvement. For now, we need to be financially smart in all decisions that we make. This includes, but is not limited to convention. I will do my best, as your Treasurer to stand strong in my conviction that our funds belong to the members and it is them that we are here to serve, and it is our responsibility to ensure that TREA is able to continue its mission "to enhance the quality of life for uniformed services enlisted personnel, their families and survivors – including veterans, active components, reserve components, and all retirees; to stop the erosion of earned benefits through our legislative efforts; maintain our esprit de corps, dedications and patriotism; and to continue our devotion and allegiance to God and country". (TREA's Mission Statement – quoted)

The FY 2018 audit follows this report. It is extremely important for you to understand that the income TREA received in 2018 was derived from isolated events. These unique opportunities will not happen again. The income included the sale of the Headquarter building, the final disposition of NAUS and a onetime grant from the Memorial Foundation for Scholarships. This made up the 2018 income that is reported in the audit. Although it appears that TREA made a large net profit for FY 18, the financial fact is that, we actually had a rather large operational deficit. Let me explain – TREA's operations (Membership, fundraising, convention, The VOICE magazine – basically everything that TREA has control over) resulted in a \$280K loss for the year. Fortunately, we had the abovementioned exclusive financial windfalls that allowed us to show a net profit...on paper. We must be forever vigilant as this perceived profit can lead one to believe that TREA is financially stable and this is just not the fact. We do not have another building to sell and as far as we know, there is not another organization coming our way. We must find a way to be self-sufficient.

The proposed 2020 budget follows the audit report. The Finance Committee and the TREA BOD put a lot of time and effort into the FY20 budget, but as you can see, we have been forced to use the investment funds to balance the budget. Investment funds should never be considered a source of income. This practice of using investment funds to balance the budget is not solid business practice.

For many years we have talked about 'change'. TREA is making changes and I hope that you can see them. One of the biggest efforts can be seen in the Legislative Office. The modification in the title of Director (and Deputy Director) of Legislative Affairs, to Director (and Deputy Director) of Veterans and Military Policy. This change updates the positions and their responsibilities to be more on par with those of other VSO organizations. When in DC, it is important to be seen as equal to your counterparts, it all starts with the title – it needs to demand recognition. With this new title comes a new face - Ken Greenberg, the new Director of Veterans and Military Policy brings a world of experience and knowledge to the position and has made tremendous progress in the short time he has been with us. This is just the beginning, more progress and innovative developments will be coming. It is in the proper understanding behind these transitions that lies our successful future.







CONVENTION UPDATES Phil Hilinski, President







This change defines how a spouse membership will be handled in the case of a divorce from the military member.

Article III, Section 1 / Membership

This change will undo the change approved in 2018, in allowing spouses to become members of TREA.

Committee Recommendation: N/A National Board Recommendation: Disapproval

Article V, Section 1 / Elected Officers

This change would eliminate 2 of the Director positions Committee Recommendation: Approval National Board Recommendation: Approval

Article X, Section 1a / Frequency

This change simply eliminates the word (convention) and leaves everything else the same.Committee Recommendations:N/ANational Board Recommendation:Approval

Article X, Section(s) 3-5 / Membership Sessions

This submitted changed incorporates several changes:

Basically it allows every TREA member the ability to vote in person, by mail or by internet-based voting system. This change eliminates the Chapter Delegate system that is currently based on Chapter numbers. Because of the ability to vote in person, by mail or by internet-based voting system, the need for proxy voting is eliminated.

CONGRESSIONAL DEBATE ON SOCIAL SECURITY REFORM CONTINUES TO EVOLVE - By Jessie Gibbons, Legislative Director



In recent years, the Social Security reform debate has shifted from one centered around benefit cuts to one focused on benefit enhancements. I have witnessed this evolution first-hand while working for The Senior Citizens League (TSCL) over the past nine years. This summer I will be leaving The Senior Citizens League's legislative team and moving back to my home state of Wisconsin. While planning ahead for my move, I couldn't help but reflect on the past to the first congressional briefing I attended back in 2010.

It was a meeting of the National Commission on Fiscal Responsibility and Reform – an eighteen-member Presidential Commission that was tasked with reducing the federal deficit. In their final report, members of the commission recommended several Social Security benefit cuts to accomplish that goal, including increasing the eligibility age and

cutting the annual cost-of-living adjustments (COLAs).

Due to the efforts of TSCL and other advocacy organizations, the plan released by the commission in 2010 failed to win the votes it needed to advance in Congress, and the Social Security reform debate has been evolving ever since. Fast forward nine years: I was recently excited to attend one last congressional hearing on the topic of Social Security reform before leaving Washington, D.C.

The final hearing I attended was titled "Protecting and Improving Social Security: Comprehensive Legislative Proposals to Enhance Social Security," and it was a far cry from the commission meeting I attended back in 2010. At the hearing, lawmakers on both sides of the aisle agreed that Congress must prioritize three Social Security reforms in particular: improving benefits for widows and widowers following the death of a spouse, creating a new special minimum benefit for those who worked long careers in low-paying jobs, and addressing the inequities created by the Windfall Elimination Provision that impacts millions of teachers, police officers, and other public employees.

Lawmakers at the hearing also discussed the Social Security 2100 Act (H.R. 860), which was introduced by Social Security Subcommittee Chairman John Larson (CT-1) earlier this year with the support of more than 200 cosponsors. That's more than any other Social Security reform bill in recent history. The bill, which has been endorsed by The Senior Citizens League, would strengthen Social Security benefits while improving the program's solvency through the remainder of this century.

If adopted, the Social Security 2100 Act would base COLAs on the more adequate Consumer Price Index for the Elderly (CPI-E), boost Social Security benefits by 2 percent, create a new minimum benefit set at 125 percent of the poverty line, and cut taxes for millions of seniors with modest incomes who currently pay taxes on their benefits. It would cover the cost of these reforms and improve the solvency of the program for decades to come by applying the payroll tax to income over \$400,000 and by gradually increasing the payroll tax rate from 6.2 percent to 7.4 percent.

Following the Social Security reform hearing, The Senior Citizens League submitted a statement to the subcommittee expressing our support for the Social Security 2100 Act, and thanking Chairman John Larson (CT-1) and Ranking Member Tom Reed (NY-23) for their bipartisan commitment to strengthening the Social Security program. In the months ahead, The Senior Citizens League will monitor the Social Security reform debate as it continues to evolve on Capitol Hill, and will advocate tirelessly for policies that would strengthen and improve the program for current and future beneficiaries. 

CHAPTER 16 – KANSAS



President Hilinski, 2nd VP Jump, and Director Greenberg engaged with representatives of 13 other VSOs/ MSOs to review H.R. 663 – Burn Pit Accountability Act and HR. 2617 – OATH Act. The brainstorming session led to a listing of ideas to include in an Omnibus Toxic Exposure bill being developed by the TEAM. TREA is pleased that the 2019 NDAA includes several provisions addressing burn pits, and numerous provisions related to toxic exposure. The Military Coalition (TMC) Meeting

Director Greenberg introduced President Hilinski and 2nd VP Jump to The Military Coalition (TMC). TMC is a 32-member group representing military, veteran and uniformed services organizations. By working together on issues of mutual agreement, the participating organizations can harness the grassroots support of more than 5.5 million members plus their families and accomplish far more than by working on initiatives separately.

The meeting featured reports and updates on Congressional actions related to both retired and active duty service members. Issues included: (TRICARE, concurrent receipt, pay raise), Survivor Benefits, (SBP/DIC offset), Taxes, (Work Opportunity Tax Credit), Veterans, (Navy Blue Water signed into Iaw, MISSION Act, toxic exposure, mental health) Health Care (Defense Health Agency and Military Treatment Facilities, Elimination of Medical Billets, TRICARE – new contracts T-5).

TREA supports Student Loan Education Debt Relief -- Contact your Congressional Members in the House and Senate and ask them to support H.R. 3598 and S. 2049.

Legislation in the House (H.R.3598) and Senate (S. 2049) would provide disabled veterans with student loan relief. Entitled the Federally Requiring Earned Education-Debt Discharges for Veterans Act (FREED Vets Act) the bill requires the U.S. Department of Education to automatically discharge federal student loan debt for eligible permanently disabled veterans. House Veterans Affairs Committee Vice Chair Connor Lamb (PA-17) and Senate Veterans Affairs Committee Chairman Johnny Isakson (GA) and Senate Armed Services Committee Ranking Member Jack Reed (RI) are leading the effort in Congress.

The U.S. Department of Education established a program with the Department of Veterans Affairs (VA) in October 2018 to identify veterans who are disabled or unable to work. Under the current program, the Department of Education would notify veterans who are eligible for debt forgiveness of the opportunity to apply. This places the burden on the veteran to apply. The FREED Vets Act would automatically forgive these loans and eliminate the paperwork barrier that prevents eligible veterans from attaining student loan debt relief. According to the Department of Education more than 42,000 eligible veterans have been identified, yet only 20 percent of those eligible have applied for the program.

DOD extends deadline to January 12, 2020 to transfer GI Bill Benefits to Family Members

Military personnel with more than 16 years of service will have an additional six months to transfer their Post-9/11 GI Bill education benefits to family members, while Congress decides whether to remove the restriction on transfers. A new Defense Department rule originally proposed in July 2018 was set to take effect on July 12, 2019, limiting the benefit transfers to troops with at least six years of service but no more than 16 years.

The Pentagon extended the deadline until Jan. 12, 2020 for troops who have more than 16 years of service to give Congress time to discuss the House Armed Services Committee's proposal to change the rule. Troops still must have served at least six years and be able to reenlist for four more years.

Prior to the July 2018 announcement, there were no restrictions on when servicemembers could transfer education benefits to family members after they'd served six years. Servicemembers who have received Purple Heart medals are exempted from the rule.
