A Letter from the President

I want to begin by correcting a mistake I made in my column in the last issue of The Voice. I was discussing the election of our new Board of Directors (BoD) at our convention last September and I mentioned that for the first time we had a Member-At-Large elected to the Board. However, I have since found out that I was wrong. Immediate Past National President Larry Hyland was a MAL when he served on the Board as 3rd Vice President from 2002-2003 and again as the National President. My apologies to Larry.

It is my great pleasure to give you some exciting news that is rare in the history of military and veterans associations. Many of you may be familiar with another military/veteran association, the National Association for Uniformed Services (NAUS). The board of directors of NAUS made a decision late last fall to cease operations as of the end of 2016. When I went to Washington, D.C., for the annual Veterans Day ceremonies at Arlington National Cemetery a meeting was arranged for me to talk with the president of NAUS. Our discussions involved the possible transfer of the enlisted members of NAUS to membership in TREA when NAUS closed its doors.

I am pleased to report that our negotiations were successful and as of January 1, more than 10,000 former members of NAUS have now become TREA members. A letter from me to those members has been sent welcoming them to TREA, explaining the terms of the transfer of membership, as well as the opportunities they have to participate in TREA activities.

Although it is unfortunate to lose an ally in our fight to protect our promised and earned benefits like NAUS, we nonetheless are very pleased to welcome the NAUS members to TREA and we look forward to continuing to serve them and fight on their behalf just as NAUS did.

Although the transfer of NAUS members to TREA would have been worth a trip in itself, my main purpose in going to Washington was to participate in the Veterans Day Ceremonies. This was my first opportunity to represent TREA at these events and it was a very gratifying and humbling experience. There was a breakfast at the White House with representatives of the various military and veteran groups participating in the ceremonies, the members of the Joint Chiefs of Staff, the Senior Enlisted Advisors, and other guests. After breakfast, we had one-on-one pictures taken with President Obama. Then the group went to the amphitheater in Arlington National Cemetery and watched as the President placed a wreath at the Tomb of the Unknowns.

After that the other representatives of the military and veterans' groups and I sat on the stage of the amphitheater with the President as he delivered his final Veterans Day speech. As is customary, after the President's speech all of the participating military and veterans' groups presented wreaths on behalf of their respective organizations at the Tomb of the Unknowns. TREA was represented by the Auxiliary National President Irmgard Cates, Michael Gales of TREA Chapter 9, Mr. Paul Chester of TREA Chapter 1, and myself.

I want to give special thanks to the TREA members of Chapter 9 in Baltimore, and TREA Chapter 24 in Ft. Meade, Maryland. Every Memorial Day and Veterans Day these folks faithfully represent TREA at Arlington, carrying the American and TREA flags in the opening and closing ceremonies in the Amphitheater as well as presenting the TREA wreath at the Tomb of the Unknowns. They are very much appreciated and we are very thankful for their willingness to do this.

I also want to thank the members of TREA's staff in Colorado and our Washington, D.C., office who were instrumental in the negotiations with NAUS and in making sure our participation in all of the events on Veterans Day went so well.

As we begin a new year with a new president we are all waiting to see what may happen. As this is written, no announcement has been made about who will be nominated to be the next Secretary of Veterans Affairs. Some of the names that have been mentioned are very troublesome and if nominated, we may have our hands full fighting to save many of the veterans benefits we now have through the VA. At this point I remain optimistic that the worst case won't happen but we shall see. At any rate, all of the talk about cut-backs and reduced spending will continue and we expect to have our hands full fighting to keep things like our Tricare health care and commissary benefits in the coming months and even years.


I hope each of you had a wonderful holiday season with your family and friends and I wish you the very best in this new year. You can be assured that TREA is standing guard for you in Washington.

A Little Goes A Long Way

Have you ever had a small thought that turned into a big plan that grew into a huge program?

While attending a business seminar, I got involved in a conversation with Jennifer Cernoch, the Vice President of Operations for Soldiers' Angels - a nonprofit, resource organization that links soldiers & veterans up with organizations across the country. It was the end of October, so of course our conversation easily found its way to the holidays and to Christmas. She told me about one service member who was struggling to provide a decent Christmas for his family back home while he was deployed in Africa. My heart overtook my mouth and I heard myself saying out loud 'I'll take them' - without even asking what the program was or how it worked. Honestly, it didn't matter, I was going to help this family out no matter what. That is when the little shine of a nightlight came on - I told myself that 'I work for an organization that does this - how can I get TREA and The Memorial Foundation involved?' After much more discussions with Ms. Cernoch, I told her that we were going to help. By now, that little nightlight is a bright beacon, trying it's best to blind me! I asked her what it would take for us to adopt a family in every state across the country. Her eyes lit up and she didn't answer right away - I think she thought

that I was joking. I was not.

Well the seminar continued over the next two days and we really didn't discuss it much more. It wasn't until I got back to the office that the work really began. I reached back out to Ms. Cernoch and again, reiterated my desire - for TREA and The Memorial Foundation to adopt 50 families across the country. Aside from the genuine desire to help these families, it would be such a good opportunity for people across the country to know that we are here to help and that we do great things for our military members and veterans.

I immediately contacted all the powers-that-be to try to convince that that this is something that we needed to do. It wasn't hard. Everyone rallied around the idea and approval was given to adopt and support 50 families across the country. - Game On!

We received the information from Soldiers' Angels – a very comprehensive list – down to the last detail of the gifts that they wanted and the size of clothing that was needed. Unfortunately, (or fortunately, depending on how you look at it), not every state had an eligible family so we were not able to provide assistance in all 50 states. What we were able to do was adopt and support 50 families from Florida to Maine and DC to Oregon and many in between.

Personal phone calls were made to every family, asking where they shopped for food. Specific gift cards were bought for their store of choice, including Commissary gift cards. It was a very heart lifting day in the office as we read the letters of these families. One in particular was one young boy – probably around 12 or 13 who was asking for a black tie to wear in his school's band concerts and an electric toothbrush. I don't know why that one hit me the way that it did, but I will always remember that. A lot of the families asked for clothes – I don't know about you, but I always give my boys underwear, socks and a new toothbrush for Christmas and they hate it! They would trade those for a toy, game or money without thought and here is young boy who was actually asking for it. Certainly changed my perspective that day.

Armed with 50 shopping lists, I bribed my family to help me shop. And shop we did. Over the course of the next five days, we shopped for 72 hours (cumulative), filled 27 shopping carts, stood in lines for 8 hours and spent \$15,000.00. Back home, another 6 hours was spent separating, organizing and labeling over 2000 items. At the TREA Headquarters, gifts were piled high against every wall, bags of toys and clothes blocked every walkway. It was wonderful!! Staff and volunteers came in to wrap - for three days! We are almost finished --- or were we?

In a status report to the Memorial Board of Trustees, I was ranting and raving about how wonderful the program was, and about these families and how much we were helping and that is when it happened --- they voted to take on another 50 families. Now, I'm looking at the calendar, it's December 14th – wondering how in the world we could possibly shop, wrap and ship another 50 gifts while still doing our regular full time jobs. Granted, we never said 'no', we just said 'how'. It was agreed that the second group of families would receive \$250 in gift cards. This would make it possible for all the families to receive their package before Christmas. – Whew, almost done --- nope, not yet.

When the call was placed to Soldier's Angels to announce that TREA and the Foundation were adopting another 50 families, they made the mistake of saying 'that is so great, now we only have 38 more families to find adopters for' – you know what happened next. Yep, the Trustees voted to take on those extra 38 families! 'We can't adopt 100 families and leave the last 38.' Trustee Roger Tackitt said. The vote was unanimous. Back to store to get more gift cards.

In the push of the last few days, other organizations and individuals came forwards and adopted some of those last 38 families, leaving only 3 for us to adopt. I am thrilled to announce that every family that was on the Soldiers' Angels list was adopted – over 1100 of them!

It's still not over ---- it keeps getting better. TREA Chapter 39, from Aurora Colorado was on board with this program from the beginning. They adopted 5 families from the program. They chose local families and personally delivered gift/meal baskets to each one.

In another part of this magazine, you will read about a middle school who held a special Veterans' Recognition night of which TREA was a guest. Mesa Middle School in Castle Rock, Colorado used the funds that were raised that night to adopt a family from TREA in support of this program.

Last but certainly not least, The Foundation provided \$350.00 gift cards to 5 families of the ESGR.

After a total of 76 hours of shopping, 27 shopping carts, 10 rolls of wrapping paper, 14 hours of wrapping, 6 boxes of cards, 10 bags of candy, 14 hours standing in line (between the stores and the Post Office) and spending \$30,650 – the last box was shipped out.

A lot of work, a ton of effort and it was worth every bit to accomplish such a wonderful, giving show of support for our veterans and military members.

This was just the beginning – because of this, the Foundation has added the new 'Holiday Assistance' Program to their list of programs and services. If we can help, then we should – and we will.

I am proud and honored to have been a part of this program – these veterans and soldiers, and their families have fought for and are continuing to fight for us. It is our duty and our responsibility to support them and offer assistance when and where we can.

Since this will be an ongoing program, I will be reaching out for volunteers next year – please keep this in mind. A little help goes a long way.

A special thank you to everyone who helped in this monumental task: The TREA HQ staff (Hazel Simeon, Tanya Austin & Susan Dunn), the Members of the Foundation (Chairman Mark Tabacheck, Trustee Roger Tackitt, Trustee Mel Yell, Vice Chairman Butch Liebaert & Parliamentarian Bob Corson), my family (Sherri Anderson, Doug, Michael & Christopher Osborne) and to my mom's friend Sylvia Martin for spending the day wrapping with us. We couldn't have done this without all of your help!



2016 was a big year for TREA with a successful National Convention in Las Vegas, newly elected President John Adams, preceding Past President Larry Hyland and a new direction for the United States with the election of President Donald Trump. As you know I have taken a new position as the Legislative Director. In doing my homework, researching legislative changes where access or change to benefits directly impact veterans and their families, I have found many new and improved options, but this is an ongoing process and we must stay watchful. To support one another we must communicate with each other as we journey throughout the New Year. I will keep you posted but I also need you to keep me updated with proposed changes in your area. Listed below are a few of the new benefits that I'm excited about and you should be aware of. I very much look forward to 2017 working for the membership.



Legislative Committee 2017 Updates

Medication Copayment Changes in 2017

DAV is pleased that there will be a reduction in copayments for many service-connected veterans in accordance with DAV Resolution No. 135.

VA issued final regulations set to take effect February 27, 2017, changing VA's current copayments structure for each 30-day or less supply of medication and how future year copayment amounts and annual caps are calculated.

Veterans who are currently exempt from medication copayments remain exempt, including but not limited to, a veteran with a service-connected disability rated 50 percent or more, medication for a service-connected disability, and a former prisoner of war.

Currently, Priority Group (PG) 2-6 veterans must pay \$8 for each 30-day or less supply of medication and PG 7-8 veterans must pay \$9. Under the new rule, VA will essentially assign three categories for medication and associated copayments:

Tier 1: preferred generics - \$5 copayment for 30-day supply; Tier 2: non-preferred generics - \$8 copayments for 30-day supply; and Tier 3: brand name drugs - \$11 for 30-day supply.

In addition, current copayment costs for veterans in PG 2-6 is limited to a \$960 annual copayment cap and PG 7-8 veterans have no protections afforded by a cap. Under the new rule, VA will reduce the annual copayment cap to \$700 for all veterans, including PG 7-8 veterans, who are required to pay medication copayments.

It is estimated that a large majority of veterans will encounter no cost increase, or will realize savings, while a small percentage of veterans-veterans who only fill Tier 3 medications-may experience a small increase in medication copayments. Based on a comparison of the current and proposed copayment amounts, VA anticipates that most veterans would realize between a 10 and 50 percent reduction in their annual pharmacy copayment costs. VA also estimates, 94 percent of copayment eligible veterans will experience no cost increase, and 80 percent will realize a savings of between \$1 and \$4 per 30-day supply of medications.

VA National Cemeteries Now Offering Pre-Need Eligibility Determinations

Washington --- The Department of Veterans Affairs (VA) today announced it now provides eligibility determinations for interment in a VA national cemetery prior to the time of need. Through the Pre-Need Determination of El-

igibility Program, upon request, individuals can learn if they are eligible for burial or memorialization in a VA national cemetery.

"My VA is about looking at VA from a Veterans' perspective, and then doing everything we can to make the Veteran Experience effective and seamless," said Secretary of Veterans Affairs Robert A. McDonald. "This new program reaffirms our commitment to providing a lifetime of benefits and services for Veterans and their families."

Interested individuals may submit VA Form 40-10007 (<http://www.va.gov/vaforms/va/pdf/VA40-10007.pdf>), Application for Pre-Need Determination of Eligibility for Burial in the VA National Cemetery, and supporting documentation, such as a DD Form 214, if readily available, to the VA National Cemetery Scheduling Office by: toll-free fax at 1-855-840-8299; email to Eligibility. Pre-Need@va.gov (mailto:Eligibility.PreNeed@va.gov); or mail to the National Cemetery Scheduling Office, P.O. Box 510543, St. Louis, MO 63151.

VA will review applications and provide written notice of its determination of eligibility. VA will save determinations and supporting documentation in an electronic information system to expedite burial arrangements at the time of need. Because laws and personal circumstances change, upon receipt of a burial request, VA will validate all pre-need determinations in accordance with the laws in effect at that time.

VA operates 135 national cemeteries and 33 soldiers' lots in 40 states and Puerto Rico. More than 4 million Americans, including Veterans of every war and conflict, are buried in VA's national cemeteries. VA also provides funding to establish, expand and maintain 105 Veterans cemeteries in 47 states and territories including tribal trust lands, Guam and Japan. For Veterans buried in private or other cemeteries VA provides headstones, markers or medallion to commemorate their service. In 2016, VA honored more than 345,000 Veterans and their loved ones with memorial benefits in national, state, tribal and private cemeteries.

Eligible individuals are entitled to burial in any open VA cemetery, opening/closing of the grave, a grave liner, perpetual care of the gravesite, and a government-furnished headstone or marker or niche cover, all at no cost to the family. Veterans are also eligible for a burial flag and may be eligible for a Presidential Memorial Certificate.

Information on VA burial benefits is available from local VA national cemetery offices, from the Internet at www.cem.va.gov (<http://cem.va.gov/>), or by calling VA regional office toll-free at 800-827-1000. To make burial arrangements at any open VA national cemetery at the time of need, call the National Cemetery Scheduling Office at 800-535-1117.

Press Release - November 29, 2016 Rep. Stewart's Veterans Tricare Choice Act Passes the House

Washington, D.C. – Rep. Chris Stewart's (R-Utah) Veterans TRICARE Choice Act, unanimously passed the House today, giving Veterans more healthcare options.

This bill, H.R. 5458, is a bipartisan, common sense piece of legislation that allows veterans to temporarily pause their TRICARE benefits to participate in an employers Health Savings Account (HSA) program if they so choose.

Health Savings Accounts have proven to be an effective way to pay for medical costs and proactively save for future medical expenses. They have become increasingly popular healthcare plans in the private sector, but under current federal law, it is illegal for a TRICARE-eligible veteran to participate in an HSA program.

The Veterans TRICARE Choice Act simply gives veterans the choice to voluntarily pause their TRICARE benefits in order to participate in an HSA program.

"Our veterans deserve our most profound gratitude," Stewart said. "Nothing about their military service should prevent them from accessing the same benefits as their non-veteran co-workers. The very least we can do is ensure they receive the benefits we've promised them, and that the process goes as smoothly as possible. We still have a lot of work to do on that front, but the passage of this bill is a great step in the right direction."

Following the bill's passage, Rep. Tulsi Gabbard (D-HI), the original Democrat co-sponsor of the bill said, "As a soldier and a veteran, I have seen firsthand the tremendous sacrifice our veterans and their families make in service to our country. That service should never limit their access to quality healthcare, and the ability to make decisions about their own health. The Veterans TRICARE Choice Act gives our veterans the ability to choose the best healthcare options for themselves and their families."

The Veterans Tricare Choice Act has the support of the Association of the United States Navy (AUSN) and the National Guard Association of the United States (NGAUS).

Critical Vote on Veterans Legislation Needed in the Senate

The Senate Veterans' Affairs Committee has approved and reported a nearly 400-page omnibus measure now pending a vote by the full Senate. This bill, S. 2921, the Veterans First Act, contains numerous DAV legislative priorities that would expand and improve benefits and services for injured and ill veterans, including DAV members and their families.

This legislation would extend comprehensive caregiver support to veterans of all eras; increase veterans' options for long-term care through medical foster homes; enhance VA's efforts to recruit and retain the best and brightest medical professionals; reform claims and appeals processing by creating a fully developed appeals pilot program; and, make dozens of other positive changes to improve the lives of those who served.

With the House having already passed nearly two dozen measures to strengthen veterans programs, we look forward to working together with leaders in both chambers of Congress, the VA and other key stakeholders to enact comprehensive legislation to help keep the promise to America's veterans, particularly those who were injured or made ill from their service.

Please use the prepared message to write your Senators today to ask them to work for a final vote on S. 2921, the Veterans First Act, which will improve the lives of millions of America's veterans, as well as their families and survivors.

As always, thank you for your support of DAV's legislative efforts. Your participation in DAV can make DAV a more effective advocate to protect and enhance the interests of veterans who have sacrificed in military service to America.





MEMBERSHIP APPLICATION

- **Associate Membership:** Widows/Widowers of members and non-members, who were eligible for membership at the time of their death, are eligible to join TREA: The Enlisted Association as associate members. 2017-2018 Memorial Scholarship

Do you think that there should be a term limit for our National House of Representatives and Senator's? Please give your opinion on why you think there should be a term limit (Number or years) or no term limits.

You may have noticed the 13 pictures of recipients who received a scholarship for the 2016/2017 school year. We actually gave out 25 awards totaling \$28,000.00 dollars, but several recipients did not submit their photos for publication. This year, it is a requirement to submit a picture and a signed PR Release form. The Foundation does so many wonderful things, that we only think it is fair to spread the word and let everyone know everything that we do. The more people who know about our good deeds, the more veterans (and their families) can benefit from our services.

Since this program was started, we have given approximately 650 Scholarships worth over \$530,750.00. We are proud to have been able to award these scholarships and will continue to do so as long as we are able. Your support will help this wonderful program.

Election Perspective: History and the Future

With a New Year now well underway and the holidays behind us, the country goes back to the business of being itself. We have to look ahead and see what we are going to do as citizens and watch our leaders as they grab the reigns of power and move forward. It has been a rough journey for many. There were a lot of surprises and a lot of surprised “experts” who got the outcome wrong. We know now what our leadership will look like and we have heard their message. The question is, have they heard ours? What can we do?

The promise of a chance to change our President every four years and to hold elections for all of our key leaders is the centerpiece of our democracy. It is at the very heart of our principles. The Founding Fathers envisioned the process carefully in the way they constructed the balance of power, and in the subsequent establishment of the electoral college to ensure that we the people would retain the ability to make peaceful changes when we need to. Later limits to terms, guarantees us that we will have a chance to make change at least every four years. This “bloodless revolution” is also what motivates many to serve, as TREA members well know, and what inspires other countries around the world to try to emulate what we have here. It is special.

In this past election, the results yielded new Republican leadership. The overall outcomes were strongly in their favor. Donald Trump won the electoral college with 306 votes to Hillary Clinton’s 232, so although he did not win the popular vote – by over 2 million votes – he becomes the 45th President of the United States. Republicans also hold the Senate with 52 vs. 48 for the Democrats and the House of Representatives with 241 vs. 194 for the Democrats. (218 are needed for control there.) In gubernatorial races, we have 6 Republican Governors and 6 Democrats assuming office.

We are not a perfect nation. Some argue now that we are a divided nation. Others say this was the most contentious election in history, but a little digging reveals there are many historians who feel we have had far more heated races going back in our history.

The one most often cited first is the election of 1800 between Thomas Jefferson and John Adams. The country was young and the rules were quite different. The hit musical “Hamilton” deals with the saga, the mudslinging was epic and emotions ran high. “Jefferson’s side started by calling Adams a “hideous hermaphroditical character, which has neither the force and firmness of a



man, nor the gentleness and sensibility of a woman.” Adams supporters responded by labeling Jefferson “a mean-spirited, low-lived fellow, the son of a half-breed Indian squaw, sired by a Virginia mulatto father.”²¹ Pretty strong language then or now. In the end the decision ended up being made by the House of Representatives. The 12th Amendment also was added to clear up the election process further and to ensure “electors vote separately for the two highest offices.”²²

In 1824, it was John Quincy Adams vs. Andrew Jackson. Jackson, “Old Hickory”, as he was called, was a war hero from the War of 1812. He did win the popular vote but neither man carried the majority in the electoral college that was required. Once again, the House of Representatives decided on the Presidency. The third party candidate finally dropped out after months of behind the scenes discussion and was eventually named Secretary of State. Andrew Jackson was so upset, he quit the senate and went on head the new Democrat Party and come back in 1828 to win the Presidency.

In 1860 it was Stephen Douglas vs. Abraham Lincoln. The country was on the brink of war and as Lincoln stood at the helm of the new young Republican Party, he was not even on the ballot in most of the southern states. Lincoln went on to win just 40% of the popular vote in the northern states and the votes were split as were the parties. A few short weeks after Lincoln took office, South Carolina seceded and six other southern states soon followed. The bloodshed and division of the country was the worst in our history.

1876 is one that flies under the radar for many, but it was brutal and the consequences were far-reaching. The Democrat Governor of New York, Samuel Tilden, did win 250,000 more ballots than his rival, Rutherford B. Hayes, but he was still one electoral vote short of the win. Three states remained too close to call and an elector out west (Oregon) was replaced suddenly. The country was still raw from the civil war and the threat of more war loomed, so Congress intervened, establishing a panel of 15 members (senators, congressmen, and Supreme Court justices) with 7 on each side and one independent and they decided the election! Democrats accepted Hayes’s victory but only on the condition that federal troops were removed from the south. This ended Reconstruction and reversed “the gains that African-Americans had made in the post-Civil War era.”²³

In 1912, Theodore Roosevelt thought he had it all figured out. He had named a successor, William Howard Taft, but then became upset as Taft drifted too far to the conservative side. When Roosevelt lost a challenge in the primary, he created his own party (The Progressive Party) and ran anyway. Effectively, they split the vote and Woodrow Wilson won the White House even though he had less than 50% of the vote in most states. Famously in this race Roosevelt was shot delivering a speech and continued to its conclusion anyway!

Most remember the image from the 1948 race between Dewey and Truman. Truman was believed to be on the way out. His support of civil rights cost him the conservative southern Democrats who would later come to be known as “Dixiecrats”. He went to bed thinking he had lost only to find out in the morning he had not. His whistle stop tours of the country making a case that a Republican would undo much of the New Deal, helped many to believe that is what ended the Depression and brought him to victory.

And then finally, on most lists, is the 2000 election between George H. Bush and Al Gore. In this case, it took the Supreme Court ruling - 5 weeks after the election - to stop the vote recount that had been going

on in Florida, giving Bush a 5-point majority in the electoral college though he had not won the popular vote.

So, we see that despite the rough language and ugly nature of this last election, it has not been “the worst we have ever had”. We tend to romanticize history a bit and forget that we have a long tradition of tough campaigns which are soon forgotten when the leadership is finally established. Though it may not feel like a perfect process, historian and professor Thomas Schwartz of U.S. Foreign Relations and the presidency at Vanderbilt University may have said it best.

“We’ve had bitter elections, but the process itself has been established as absolutely fundamental. And I think that is, in part, because the great national tragedy of American history is the Civil War and the almost 750,000 people killed in that conflict. We’ve come to terms with it because it ended slavery, but it still was a disaster for the country, and it’s not something anyone wants to see repeated.”²⁴

...Something we never want to see repeated. We are “one nation indivisible” and we have to work hard to remain as such. Now is not the time for bitterness and division, it is time for us to engage, to be aware, to keep our politicians in check and accountable, and to work together to ensure that our communities are strong and undivided as well. It is of course true that the President and Congress hold great power, but when you think about your day-to-day life, isn’t the greater impact felt at the local level?

That is one thing that makes TREA members great - participation at the grass roots. You just need to flip through this magazine and past issues to see all of the wonderful work - time and energy - being spent to improve the lives of those around us. That is what will make a difference and that is what really makes America great. Arguably, that is what will continue to do so. People helping people. People being kind. People being the best reflection of leadership and generosity that that they can be. That is us. That is America.



Let Us Remember and Honor Our World War II Missing

Unless we lived in the era of World War II we may not know the following facts about World War II. Most of us probably had family members who served during that time but they have more than likely left us as the years have passed by. I think it is important to remember our history, not only for knowledge but to honor those who fought and those who died, and those who served as support personnel both at home and abroad. There were many .

World War II took place during 1939-1945 and, according to the website Answers.com, of the 16,596,639 servicemen who fought for the US in World War II, 416,837 lost their lives: 318,274 from the Army and Air Force, 62,614 from the Navy, 24,511 from the Marine Corps, 1,917 from the Coast Guard and 9,521 from the Merchant Marines. There were 643,846 wounded and also 1,700 civilian deaths.

World War II is considered the largest and deadliest war in history. Military battles were fought in Europe, in the Mediterranean, in the Soviet Union, in Africa, in the Pacific and many other places that we never hear about. It was truly global in scope and, although it is nearly 80 years in our past I feel we need to reflect on what it took to stand firm, no matter the cost, to ensure that when one nation invades another as Germany invaded Poland, much of the rest of the world took a stand against an oppressor whose desire was to change the world into the image that would not be one where all men were created equal, but where genocide was an acceptable practice.

Possibly 62 million people lost their lives during this war including 12 million lives lost in the Holocaust. Approximately 80 percent were on the Allied side and 20 percent were on the Axis side. The Soviet Union suffered the largest death toll with approximately 23 million dead.

We have all heard and we all know that the price of freedom is not free. The staggering cost in lives during these 6 years, not counting the monetary costs to bring the Axis aggression to a halt shows us this as a reality that cannot be denied.

We have all heard and we all know that the price of freedom is not free.

So many of those who fought were never found and never brought home to be honored for their service and their sacrifice. The remainder of this article addresses those who are still missing. The information came from the Defense POW/MIA Accounting Agency. The missing are being found and the most recent names are listed at the end of the story.

World War II Accounting

Of the 16 million Americans who served in World War II, more than 400,000 died during the war. At the end of the war, there were approximately 79,000 Americans unaccounted for. This number included those buried with honor as unknowns, officially buried at sea, lost at sea, and missing in action.

Today, more than 73,000 Americans remain unaccounted for from WWII.

At the war's end, American casualties remained unaccounted for around the globe, some where they had fallen, some in the depths of the oceans, and many in temporary cemeteries scattered throughout the world where battles occurred.

Following the war, the United States (U.S.) Government launched a global initiative called, "The Return of the World War II Dead Program," to locate aircraft crash sites, comb former battlefields for isolated graves, and disinter temporary military cemeteries around the globe. The U.S. Army created the American Graves Registration Service (AGRS) to perform this task. Once remains had been recovered, they were transported to Central Identification Laboratories (CIL), where technicians confirmed or established identifications of more than 280,000 individuals. The identified service members were then buried according

to the wishes of their next of kin. The program operated from 1945 to 1951, working until all known leads were exhausted. The Army program was a worldwide endeavor employing approximately 13,000 personnel, and costing \$163.8 million in wartime dollars.

After the end of the official program for returning the dead of WWII, the U.S. Army Mortuary system continued to recover and identify smaller numbers of WWII service members. These identifications stemmed largely from reports of remains discovered by the citizens of the countries where the casualties occurred. Upon receipt of such a report, a mortuary team would investigate, recover, and identify the remains. As a result, more than 200 additional service men were identified between 1951 and 1976.



After 1976, the task of recovering and identifying the remains of WWII service members fell largely to the U.S. Army Central Identification Laboratory in Hawaii (CILHI). From 1976 to 2003, that organization sent recovery teams into the field using anthropologists and ordontologists to identify an additional 346 individuals. In 2003, CILHI merged with Joint Task Force-Full Accounting (JTF-FA) to form the Joint Prisoner of War/Missing in Action (POW/MIA) Accounting Command (JPAC). JPAC accounted for an additional 300 individuals.

In 2003, historians at the Defense Prisoner of War Missing Personnel Office (DPMO) began to develop a comprehensive database of WWII service members whose remains were not recovered or identified after the war. This database was a significant step in creating a comprehensive plan to research WWII missing personnel.

Historians from DPMO were primarily responsible for answering questions from family members about missing service members from World War II until January 2010 and the passage of the National Defense Authorization Act (NDAA) 2010. Responding to this law, the Department of Defense expanded World War II accounting efforts to more proactive case development. Historians and analysts at DPMO collaborated with JPAC in researching, investigating, and nominating for recovery the cases of U.S. casualties still missing from WWII.

In 2014, the Secretary of Defense directed that DPMO and JPAC, along with the Life Sciences Equipment Laboratory (LSEL), be merged to form the Defense POW/MIA Accounting Agency and reach full operational capability in January 2016.

The Easy Wine Guy on Another Favorite: Bourbon

The Easy Wine Guy is branching out this time to acknowledge the trends in the beverage industry, and because I happen to love bourbon, too. The biggest craze in spirits today is bourbon - single barrel bourbon, bourbon aged at sea and many others. The price can range from \$15 to \$200+ a bottle. What is the big deal? To a bourbon drinker, there are lots of nuances. Bourbon taste varies from producer to producer, so part of the fun is finding “your brand”. (This means tasting lots of different kinds of bourbons.) Expensive bourbons should be enjoyed neat or with an ice cube. A mixed drink like a classic Manhattan or an Old Fashioned can be made with well-known brands like Maker’s Mark or Bullitt. I’m not endorsing any brand in particular. I like many. You should find your favorite. I’ve added some fun facts and a few recipes to guide you along, and as the Easy Wine Guy always says...”Drink what you like-- not what is hyped!”

Fact 1: Just ‘cause it’s whiskey doesn’t mean it’s bourbon.

Bourbon is kind of like whiskey’s “sweet spot.” Because corn is a sweet grain, the more corn, the sweeter the whiskey—and bourbon needs to be at least 51% corn. Tennessee whiskey? Not bourbon. Canadian whisky? Nope. Scotch? Definitely not bourbon... you get the idea.

Fact 2: Bourbon is All-American.

In 1964, under President Lyndon B. Johnson’s administration, Congress declared bourbon “America’s native spirit”. Today bourbon is recognized around the world as America’s native spirit.

Fact 3: From barrel to bottle.

The only thing that can be added to bourbon is water (and only to bring it down to proof). Other whiskey makers can add colors (often caramel) and flavors to their products. But then, they can’t call their whiskey bourbon.

Fact 4: Bourbon must be aged in new barrels.

By law, bourbon must be aged in NEW charred oak barrels. Scotch whisky often recycles barrels first used for bourbon. Perhaps they’re hoping to steal some of the bourbon’s deep flavor and complex character.

Fact 5: The name is everything.

It can’t say “bourbon” on the label if it’s not distilled and aged in the United States. It can’t be “Kentucky Straight Bourbon” unless it’s distilled and aged in Kentucky for at least 2 years.

In case you need a couple of starter recipes, here are the classics:

Manhattan Cocktail recipe:

- 3/4 oz sweet vermouth
- 2 1/2 oz rye bourbon whiskey
- 1 dash Angostura® bitters
- 1 maraschino cherry
- 1 twist orange peel



Combine the vermouth, bourbon whiskey, and bitters with 2 - 3 ice cubes in a mixing glass. Stir gently, don’t bruise the spirits and cloud the drink. Place the cherry in a chilled cocktail glass and strain the whiskey mixture over the cherry. Rub the cut edge of the orange peel over the rim of the glass and twist it over the drink to release the oils but don’t drop it in.

Old Fashioned recipe:

- 2 oz bourbon whiskey
- 2 dashes Angostura® bitters
- 1 splash water
- 1 tsp sugar
- 1 maraschino cherry
- 1 orange wedge



Mix sugar, water and angostura bitters in an old-fashioned glass. Drop in a cherry and an orange wedge. Muddle into a paste using a muddler or the back end of a spoon. Pour in bourbon, fill with ice cubes, and stir.

The Washington Report

It is time to say good-bye to the 114th session of Congress It is time to say hello to a new Administration and to the 115th session Congress. And to our many new TREA members- Welcome Aboard.

Well it could have been a great deal worse. HAPPY 2017 NEW YEAR TO YOU ALL. At the very end of the 114th session of Congress after months and months of extremely few bills becoming laws both the National Defense Authorization Act for Fiscal Year 2017 (H.R.4909) (NDAA) and an omnibus veterans package combining parts of numerous House and Senate veterans bills were passed by Congress and signed by the President. The NDAA is over 3700 pages long and while the Jeff Miller and Richard Blumenthal Veterans Health Care Improvement Act of 2016 (H.R.6416) is a mere 57 pages it is so full of provisions that the Library of Congress is still trying to write a summary of the bill. Some of the important provisions are:

- Streamlining portions of the application process for veterans, their families and their survivors to obtain disability compensation and benefits at the VA;
 - Expanding the U.S. Court of Appeals for Veterans Claims from seven to nine judges to help address the large backlog of veterans' appeals and speed up final adjudication of appeals;
 - Extended the legal definition of "veteran" to Guard and Reserve members who served at least 20 years but have not been called up for more than 179 consecutive days of federal active duty.
 - Provides an extension of time for surviving spouses who lost their husband or wife on September 11th 2001 or in the early years of the wars in Iraq and Afghanistan to use the Gunnery Sergeant Fry Scholarship
 - Make changes to the VA's burial benefits and interment policies, including expanding eligibility for presidential memorial certificates to certain individuals who served in reserve units of the Armed Forces, among others;
 - Made improvements to how the VA administers and approves education benefits for veterans and will allow mobilized reservists to keep their GI Bill eligibility when a deployment interrupts their schooling;
- "Make improvements to the VA's health care services and benefits to include:
- Ensuring preventative health services for veterans include access to adult immunizations for veterans who wish to receive them;
 - Prioritizing access to care for medal of honor recipients;
 - Ensuring veterans who served in classified missions can access mental health care without disclosing classified information;
 - Requiring the VA to submit an annual report to Congress regarding the provision of hospital care, medical services and nursing home care by the Veterans Health Administration;
 - Expanding the qualification criteria to make it easier to hire qualified mental health care professionals;
 - Enhancing research on the potential health effects from toxic exposures to veterans and their descendants."
 - Increase access to benefits for homeless veterans.

The National Defense Authorization Act (NDAA) is a behemoth that directs all the Department of Defense's spending. This year's defense budget is \$611.2 billion in discretionary funding which breaks down to:

- \$523.7 billion for the Department of Defense (DOD) "base budget" which funds routine activities not associated with ongoing deployments in Afghanistan and Iraq;
- \$67.8 billion for Overseas Contingency Operations (OCO) which funds operations in Afghanistan and Iraq and certain other DOD activities; and
- \$19.7 billion for national security programs of the Department of Energy and other defense-related activities.

Of course this is for the full fiscal year (October 1st 2016-September 30th 2017) At this time the federal government is running under a Continuing Resolution (CR) that expires on April 28th 2017- unless another one is passed.

Some of the approved provisions will create changes for all of America's military family. That includes active duty and their families; members of the Guard and Reserve and their families; retirees, survivors and veterans. Last year Congress focused on retirement and compensation. This year they focused on TRICARE. Congress promised that none of the changes would affect anyone who is already retired or presently serving and that is what they did- at least technically. If you are a TRICARE for Life beneficiary you will see no changes. They have also not focused on TRICARE Prime which is essentially a military HMO.

It abolishes TRICARE Standard, TRICARE Extra, and the other TRICARE Programs and creates a new TRICARE Select which is like a PPO. It creates an open enrollment period and increases enrollment fees, deductibles, catastrophic caps, and copayments for beneficiaries in the retired category and active duty family members who join the military on or after January 1, 2018. It also puts military treatment facilities (MTFs) under the new Defense Health Agency. These are all big changes and we don't know how they will change the whole military health care system. But is one of our most important jobs in Washington to keep a sharp eye on what is happening and how it will affect you.

And when we think of you there is another huge change this year. We are welcoming almost 10,000 new members from NAUS. Of course we know many of you very well. TREA and NAUS worked together for many years. To improve and protect your benefits. To keep you informed. To urge Congress, federal agencies and departments of changes that you desired. To make sure your voice is heard throughout Washington and much more. But surely there are projects and concerns and proposals that you have supported that we do not know about. And we want to know about them. So please call or e-mail us and tell your new people in Washington what your thoughts are. (That is also a request to our longtime members) It is a brand new year. A brand new President and Executive Branch and a new Congress. This is going to be a wildly interesting time. It will be an honor to work with all of you to protect and improve the earned benefits of all those who have kept us free and safe for over 200 years.

After November's highly anticipated election and an active "lame duck" session on Capitol Hill, the 115th Congress has officially begun and The Senior Citizens League (TSCL) is gearing up for another busy year. Several leading lawmakers in the majority party are vowing to seriously consider Social Security and Medicare reforms, and TSCL is working diligently to prevent harmful cuts to your benefits. In addition, with prescription drug costs soaring higher than ever before, TSCL is advocating for common-sense legislation that would improve access to affordable, life-saving medicines for older Americans.

As with the start of any new Congress, TSCL is encouraging Senators and Representatives to reintroduce key legislation, like the Consumer Price Index for Elderly Consumers Act, the Prescription Drug Affordability Act, the Social Security Expansion Act, and the Notch Fairness Act. In addition, our legislative team is working hard to build support on Capitol Hill for comprehensive reform packages that would strengthen and modernize the Social Security and Medicare programs responsibly.

TSCL's legislative agenda for the 115th Congress includes the following issues, among many others:

Social Security Cost-of-Living Adjustment – Ensuring a fair and accurate COLA that reflects the inflation older Americans actually experience.

Social Security Reform – Strengthening the financing of the program responsibly, without harsh benefit cuts for current or future enrollees.

Medicare Reform – Promoting high-quality medical care and protecting beneficiaries from changes that would increase out-of-pocket spending.

Prescription Drug Affordability – Reducing the skyrocketing costs of prescription drugs through comprehensive Medicare Part D reforms.

Social Security Notch Reform – Working towards benefit equality for victims of the Social Security Notch.

Immigration Reform – Preventing a drain on the Social Security Trust Fund by closing a loophole that pays Social Security benefits based on illegal work.

Affordable Care Act – Monitoring the law's repeal and advocating for policies that would reduce negative impacts on Medicare beneficiaries.

Prevention of Fraud, Waste, and Abuse – Ensuring that scarce Medicare and Social Security dollars are spent properly.

Social Security Disability Insurance Reform – Proposing fair and innovative solutions that would improve the financing of the program and prevent a looming benefit cut for enrollees.

TSCL's staff and all-volunteer Board of Trustees – including Legislative Liaison Michael Gales, looks forward to working with both new and veteran lawmakers this year on the issues that matter the most to our members and supporters. Throughout the 115th Congress, we will work tirelessly to ensure that Social Security and Medicare beneficiaries receive the retirement security they have earned and deserve.
